MOTION FOR ISSUANCE OF SUBPOENAS

COME NOW Respondents Chem-Solv, Inc. ("Chem-Solv") and Austin Holdings-VA, L.L.C. ("Austin Holdings") (collectively, the "Respondents"), by counsel, pursuant to 40 C.F.R §§ 22.19(e)(4) and (5), and 40 C.F.R. § 22.21(b), and respectfully move this Court for issuance of administrative subpoenas to compel the testimony of certain witnesses at the Hearing set to commence at 9:30 a.m. on Tuesday, March 20, 2012, in Roanoke, Virginia. For the Court's convenience, proposed administrative subpoenas for the witnesses identified below are attached hereto.

40 C.F.R. § 22.19(e)(4) provides that the Presiding Officer may require the attendance of witnesses by subpoena, that witnesses so summoned shall be paid the same fees and mileage that are paid witnesses in federal court, and that these fees shall be paid by the party at whose request the

witness appears. This Court therefore has the authority to issue the subpoenas requested, and Respondents are prepared to pay the required fees.

40 C.F.R. § 22.21(b) provides that the Presiding Officer may require attendance of witnesses by subpoena upon a showing of the grounds and necessity therefor, and the materiality and relevancy of the evidence to be adduced. Respondents request subpoenas for five of the eleven individuals who were named in their Initial Prehearing Exchange, filed September 8, 2011. Subpoenas for their attendance and testimony at the Hearing are necessary because these individuals are non-parties who are beyond the control of Respondents, and Respondents therefore cannot guarantee their attendance at the Hearing. Because these witnesses are expected to give testimony crucial to Respondents' defenses, the Respondents cannot rely on informal arrangements for their attendance at the Hearing. The materiality and relevancy of their expected testimony is set forth below.

- <u>Daniel Rakes</u>. Daniel Rakes is a fire official with the City of Roanoke, Virginia. Mr. Rakes is expected to testify concerning the history of the relationship between the Respondents and the Roanoke City Fire Department. He is further expected to testify concerning the character and nature of the Respondents' compliance with applicable local fire regulations. In summary, Mr. Rakes' testimony is expected to reveal that records of fire inspections do not accurately describe the level of the Respondents' compliance or non-compliance with applicable fire codes and regulations.
- 2 <u>Ronnie Campbell</u>. Ronnie Campbell is a fire official with the City of Roanoke, Virginia. Mr. Campbell is expected to testify concerning the history of the relationship between the Respondents and the Roanoke City Fire Department. He is further expected to testify concerning the character and nature of the Respondents' compliance with applicable local fire regulations. In summary, Mr. Campbell's testimony is expected to reveal that records of fire inspections do not accurately describe the level of the Respondents' compliance or noncompliance with applicable fire codes and regulations.
- 3. <u>Clay Vance Conner</u>. Mr. Conner was employed by Chem-Solv at the time of the Inspection and the Sampling Event. Mr. Conner is expected to testify concerning Chem-Solv's preparation of containers for shipment to customers.

- 4. <u>Jeffrey Shawver</u>. Mr. Shawver is a building inspector with the City of Roanoke, Virginia. He is expected to testify as to Chem-Solv's efforts to comply with all legal and regulatory requirements including the voluntary reconstruction of its Roanoke, Virginia Facility.
- 5. <u>Donald Wavne Tickle</u>. Mr. Tickle was employed by Chem-Solv as a Maintenance Manager at the time of the Inspection and the Sampling Event. Mr. Tickle is expected to testify concerning Chem-Solv's management of its inventory of sodium hydrosulfide in 2008. He is

further expected to testify concerning Chem-Solv's rinsewater management process at the time of the Inspection and the Sampling Event, including Chem-Solv's reuse of rinsewater for the purpose of rinsing off the exterior of containers in preparation for shipment to customers and Chem-Solv's use of rinsewater in the preparation of batches of FreezeCon.

Respondents further request a subpoena for Elizabeth A. Lohman, one of the six individuals

who were named in the Complainant's Initial Prehearing Exchange, filed July 1, 2011. The

materiality and relevancy of her expected testimony is as follows:

6. <u>Elizabeth A. Lohman</u>. Ms. Lohman is employed as an Environmental Program Planner with the VADEQ. According to Complainant's Initial Prehearing Exchange, Ms. Lohman is expected to testify "concerning her observations made at the facility during numerous site visits, and information about the facility obtained as part of her monitoring duty of the Chemsolv Facility. Ms. Thompson is further expected to testify in support of the allegations contained in the Complaint and in support of the proposed civil penalty." <u>See</u> Complainant's Initial Prehearing Exchange, page 3.

A subpoena for Ms. Lohman is necessary because her declarations contain statements that are in direct conflict with statements made by Respondents' witnesses, particularly with regard to the sampling event on May 23, 2007. <u>Compare</u> Declaration of Elizabeth A. Lohman, ¶¶8 and 10, <u>with</u> Respondents' Exhibit 2, ¶16, CS 004) (conflicting accounts as to whether Jamie Austin was present during the sampling event on May 23, 2007). The circumstances of the sampling event are in dispute in this case; Ms. Lohman's live testimony at the Hearing is necessary, therefore, to resolve this and other factual disputes that have implications for witness credibility and liability. Respondents cannot guarantee Ms. Lohman's attendance at the Hearing without issuance of an administrative subpoena.

Respondents therefore meet the standard of 40 C.F.R. § 22.21(b) for issuance of administrative subpoenas. Respondents have specified the expected testimony of these individuals, the necessity of this testimony, as well as its materiality and relevancy. Respondents are prepared to pay the necessary fees under 40 C.F.R. § 22.19(e)(4). Furthermore, although Respondents have sent letters to the individuals named above requesting their presence at trial, Respondents cannot guarantee their attendance without issuance of administrative subpoenas.
