## ORDER REGARDING BRIEFING SCHEDULE

On August 31, 2009, Complainant submitted to the Court a request for a "briefing schedule" with respect to the Motion for Accelerated Decision on Liability and Appropriate Penalty filed by Complainant on August 7, 2009. To date, Respondent has not filed a response to Complainant's Motion for Accelerated Decision. The procedural rules for this proceeding require a party to file its response to a written motion within 15 days of service of the motion. 40 C.F.R. § 22.16. Accordingly, Respondent was required to file its response to Complainant's Motion for Accelerated Decision by August 22, 2009. In its request for a "briefing schedule," however, Complainant related that Respondent's counsel has requested that it be allowed until September 15, 2009, to file a response to Complainant's Motion for Accelerated Decision.<sup>2</sup>

Respondent's request to file its response to Complainant's Motion for Accelerated Decision by September 15, 2009, is granted. Pursuant to this request, Complainant is directed to file its reply to Respondent's response by September 25, 2009.
