This is a civil administrative action brought pursuant to Section 14(a) of the Federal

Insecticide, Fungicide, and Rodenticide Act ("FIFRA"), 7 U.S.C. § 136/(a), for the assessment of

a civil administrative penalty against Logitech, Inc. for the sale and distribution of an

unregistered pesticide in violation of Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).

MOTION

U.S. Environmental Protection Agency ("EPA"), Region IX, filed a complaint in the abovecaptioned matter on September 24, 2010. By an order dated May 4, 2011 (the "Order"), Chief Administrative Law Judge Susan L. Biro was assigned to this matter.
