MOTION TO EXTEND TIME TO FILE ANSWER

Polycarbon Industries, Inc. ("Respondent") hereby moves pursuant to 40 C.F.R. §§ 22.7(b) and 22.16(a) for an extension of time to file an answer and written request for a hearing in this matter, presently due on or before February 1, 2019. As grounds for this motion, Respondent states that it had a conference call with EPA counsel and staff on December 20, 2018 to discuss this matter, at which it was agreed Respondent would provide additional information to EPA counsel and staff for its review and evaluation. Respondent submitted those materials on January 8, 2019; however, due to the partial federal government shutdown, EPA counsel and staff have not had the opportunity to review the submitted materials and engage in further discussions with Respondent. Respondent and EPA require additional time to review and discuss this information in furtherance of their efforts to resolve this matter without the need for further litigation.

Wherefore, Respondent respectfully requests an extension to March 1, 2019, to file an answer and written request for a hearing in this matter. Due to the partial federal government shutdown, Respondent has been unable to coordinate with EPA counsel on the filing of this motion.
