10 ORDER GRANTING RESPONDENT'S MOTION
11 FOR ADDITIONAL EXTENSION OF TIME TO FILE ANSWER TO COMPLAINT

12 By motion filed on or about December 19, 2007, the Respondent seeks an extension of time
13 to the filing of the Answer to the Complaint.

14 Section 22.7(b) of the Consolidated Rules of Practice, 40 C.F.R. § 22.7(b), provides that a
15 motion for extension of time may be granted upon timely motion of a party to the proceeding "for
16 good cause shown, and after consideration of prejudice to other parties."

17 On the basis of the Respondent's representations in its motion, including Respondent's
18 representation that the parties met on December 17, 2007 in a settlement conference wherein the
19 parties agreed to exchange information in an effort to resolve this matter without litigation and
20 Complainant's counsel agrees with the content of the Respondent's motion, it appears that there is
21 good cause for an extension of time, and there will be no prejudice to either party from granting the
22 requested extension.

23 IT IS THEREFORE ORDERED THAT:

24 The time for Respondent to answer the Complaint and request a hearing is extended to
25 February 22, 2008.
