REPORT OF STATUS CONFERENCE AND ORDER

The status teleconference in this matter was held on October 22, 2008. Participating were:

Introduction: The Presiding Officer established that the purpose of the teleconference was to assess the status of this matter.

Status: The parties' attorneys agree that the pump station that was the subject of the enforcement action was originally under Respondent's control. However, control of the pump station had since been transferred to PRASA and, as of August 2008, the pump station was in compliance. Respondent was the title holder at the time of the conference, but intended to transfer O&M to PRASA. Complainant had sent a copy of a penalty memo to Respondent's attorney, who intended to review the memo. The penalty proposal was to be amended.

The parties agreed to issue a Joint Status Report, and to a two month continuation of the status teleconference.

I have recently discovered that an Order that I drafted earlier, summarizing the status teleconference and directing the filing of a Joint Status Report, was never served on the parties. I apologize for any inconvenience and confusion this may have caused to the parties, and issue the following **Order**.

IT IS ORDERED:

The parties are to file a Joint Status Report with the Regional Hearing Clerk, with a copy to the Undersigned, no later than January 30, 2009. Based on the status of this matter as summarized in that Report, the Undersigned reserves the right to schedule a continuation of the status conference.
