

ORDER RESCHEDULING HEARING

On November 19, 2010 the undersigned entered an Order Scheduling the Hearing in this matter. Pursuant to that Order, the parties were directed to file a joint set of stipulated facts, exhibits, and testimony by February 4, 2011, and the hearing was scheduled for March 1 through March 2, 2011, in Chicago, Illinois.

Pursuant to a request by the undersigned to postpone the hearing, a conference call was held with the parties on February 3, 2011. Upon subsequent agreement of the parties, the new hearing schedule is as follows. The parties shall file a joint set of stipulated facts, exhibits, and testimony on or before June 29, 2011. See Section 22.19(b)(2) of the Rules of Practice, 40 C.F.R. § 22.19(b)(2). The Hearing in this matter will be held beginning at 9:30 a.m. on Monday, July 25, 2011, in Chicago, Illinois, continuing if necessary through July 29, 2011. The Regional Hearing Clerk will make appropriate arrangements for a courtroom and retain a stenographic reporter. The parties will be notified of the exact location and of other procedures pertinent to the hearing when those arrangements are complete. Individuals requiring special accommodation at this hearing, including wheelchair access, should contact the Regional Hearing Clerk at least five business days prior to the hearing so that appropriate arrangements can be made.

IF ANY PARTY DOES NOT INTEND TO ATTEND THE HEARING OR HAS GOOD CAUSE FOR NOT BEING ABLE TO ATTEND THE HEARING AS SCHEDULED, IT SHALL NOTIFY THE UNDERSIGNED AT THE EARLIEST POSSIBLE MOMENT.


