On November 15, 2022, the United States Environmental Protection Agency Region 3 ("EPA") and Chemalloy Company, LLC ("Respondent") entered into an Administrative Order on Consent, Docket No. CWA-03-2023-0011DN ("the Order"). In accordance with Section VII (Certification of Compliance and Request for Termination Of AOC) of the Order, by letter dated August 4, 2025, Respondent submitted a Certification of Compliance and Request for Termination of the Order for the EPA's review.

Based upon the EPA's review of information, including certifications, submitted in accordance with the Order, and additional correspondence as appropriate, the EPA believes that Respondent has adequately complied with all requirements of the Order is granting Respondent's request for termination of the Order. In accordance with Section VII of the Order, this letter serves as written notification of termination of the Order.

Please note, however, that any future noncompliance with the Clean Water Act ("CWA"), including repeated noncompliance, could result in the initiation of further review and action pursuant to the federal enforcement provisions set forth in Section 309 of the CWA, 33 U.S.C. § 1319.
