

#### PRELIMINARY STATEMENT

This administrative proceeding for the assessment of a civil penalty was instituted pursuant to Section 325(c) of Title III of the Superfund Amendments and Reauthorization Act, 42 U.S.C. §11001 <u>et seq</u>. [also known as the Emergency Planning and Community Right-to-Know Act of 1986 (hereinafter, "EPCRA")]. The "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Etc." (40 C.F.R. Part 22 (July 1, 2000)), provide in 40 C.F.R. §22.13(b) that when the parties agree to settle one or more causes of action before the filing of an Administrative Complaint, a proceeding may be simultaneously commenced and concluded by the issuance of a Consent Agreement and Final Order pursuant to 40 C.F.R. §§22.18(b)(2) and (3).

The Director of the Division of Enforcement and Compliance Assistance of the United States Environmental Protection Agency, Region 2 ("EPA or Complainant"), alleges that Colonial Wire & Cable Co. of New Jersey, Inc. located at 85 National Road in Edison, New Jersey 08817 violated the requirements of Section 313 of EPCRA (42 U.S.C. §11023) and the regulations promulgated pursuant to that Section, codified at 40 C.F.R. Part 372.



Under Section 313 of EPCRA and 40 C.F.R. §372.22, owners or operators of a facility subject to the requirements of Section 313(b) are required to submit annually, no later than July 1 of each year, a Toxic Chemical Release Inventory Reporting Form R, EPA Form 9350-1 (hereinafter, "Form R"), for each toxic chemical listed under 40 C.F.R. §372.65 and/or 40 C.F.R. §372.28 that was manufactured, imported, processed, or otherwise used during the preceding calendar year in quantities exceeding the established toxic chemical thresholds. The completed and correct Form R is required to be submitted to the Regional Administrator of the EPA and to the State in which the subject facility is located.

As an alternative to the requirements set forth above, pursuant to Section 313(f)(2) of EPCRA (42 U.S.C. §11023(f)(2)), and 40 C.F.R. §372.27, owners or operators of a facility subject to the requirements of Section 313(b), with respect to the manufacture, process or otherwise use of a toxic chemical may apply an alternate threshold of one million (1,000,000) pounds per year to that chemical if the conditions set forth in 40 C.F.R. §372.27(a) are met. If the aforementioned alternate threshold for a specific toxic chemical is applicable, such owners or operators, in lieu of filing a Form R therefore, may submit an "Alternate Threshold Certification Statement" (Form A) (see 71 Fed. Reg. 76944; December 22, 2006) pursuant to 40 C.F.R. §372.27(b). Pursuant to 40 C.F.R. §372.27(e)(3), EPA has excluded the Persistent Bioaccumulative Toxic Chemical (PBT) dioxin and dioxin-like compounds from eligibility for the Alternate Thresholds described in 40 C.F.R. §372.27(a).

EPA and Colonial Wire & Cable Co. of New Jersey, Inc. agree that settling this matter by entering into this Consent Agreement and Final Order ("CAFO") pursuant to 40 C.F.R. §22.13(b) and 40 C.F.R. §22.18(b)(2) and (3), is an appropriate means of resolving this case without further litigation. This CAFO is being issued pursuant to said provisions of 40 C.F.R. Part 22. No formal or adjudicated Findings of Fact or Conclusions of Law have been made. The following constitutes Complainant's Findings of Fact and Conclusions of Law based upon information EPA had obtained through October 1, 2008.

# FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Respondent is Colonial Wire & Cable Co. of New Jersey, Inc. (TRI Facility No.: 08817CLNLW85NAT).

2. At all times relevant hereto, Respondent has maintained a facility located at 85 National Road, Edison, New Jersey 08817 which is the subject of this Consent Agreement and Final Order (hereinafter, "Respondent's facility").

3. Respondent is a "person" within the meaning of Section 329(7) of EPCRA (42 U.S.C. §11049).

4. Respondent is an owner of a "facility" as that term is defined by Section 329(4) of EPCRA (42 U.S.C. §11049(4)) and by 40 C.F.R. §372.3.

5. Respondent is an operator of a "facility" as that term is defined by Section 329(4) of EPCRA (42 U.S.C. §11049(4)) and by 40 C.F.R. §372.3.

6. Respondent's facility has 10 or more "full time employees" as that term is defined by 40 C.F.R. §372.3.

7. Respondent's facility is in Standard Industrial Classification Code 3357.

8. Respondent's facility is in the American Industry Classification System (NAICS) Code 331422.

9. Respondent's facility is subject to the requirements Section 313(b) of EPCRA (42 U.S.C. §11023(b)) and 40 C.F.R. §372.22.

10. Antimony compounds are listed under 40 C.F.R. §372.65.

The established threshold amount for purposes of reporting under 40 C.F.R.
 §372.30 for processing antimony compounds in calendar years 2002, 2003, 2004 and 2005 was
 25,000 pounds. [40 C.F.R. §372.25(a)]

12. Respondent was required to submit a complete and correct Form R for antimony compounds for calendar year 2002 to the Administrator of EPA and to the State of New Jersey by July 1, 2003.

13. Respondent submitted a Form R to the EPA for processing approximately129,704 pounds of antimony compounds for calendar year 2002 on February 2, 2007. The Form R was greater than one year late.

14. Respondent was required to submit a complete and correct Form R for antimony compounds for calendar year 2003 to the Administrator of EPA and to the State of New Jersey by July 1, 2004.

15. Respondent submitted a Form R to the EPA for processing approximately
152,225 pounds of antimony compounds for calendar year 2003 on February 2, 2007. The Form R was greater than one year late.

16. Respondent was required to submit a complete and correct Form R for antimony compounds for calendar year 2004 to the Administrator of EPA and to the State of New Jersey by July 1, 2005.

17. Respondent submitted a Form R to the EPA for processing approximately127,567 pounds of antimony compounds for calendar year 2004 on January 31, 2007. The Form R was greater than one year late.

18. Respondent was required to submit a complete and correct Form R for antimony compounds for calendar year 2005 to the Administrator of EPA and to the State of New Jersey by July 1, 2006.

19. Respondent submitted a Form R to the EPA for processing approximately109,137 pounds of antimony compounds for calendar year 2005 on February 5, 2007. The Form R was 219 days late.

20. Respondent failed to submit, in a timely manner, a complete and correct Form R for antimony compounds for each of calendar years 2002, 2003, 2004 and 2005 to the Administrator of EPA and the State of New Jersey.

21. Copper compounds are listed under 40 C.F.R. § 372.65.

22. The established threshold amount for purposes of reporting under 40 C.F.R. §372.30 for processing copper compounds in calendar years 2002, 2003, 2004 and 2005 was 25,000 pounds [40 C.F.R. §372.25(a)].

23. Respondent was required to submit a complete and correct Form R for copper compounds for calendar year 2002 to the Administrator of EPA and to the State of New Jersey by July 1, 2003.

24. Respondent submitted a Form R to the EPA for processing approximately 78,176,948 pounds of copper compounds for calendar year 2002 on February 2, 2007. The Form R was greater than one year late.

25. Respondent was required to submit a complete and correct Form R for copper compounds for calendar year 2003 to the Administrator of EPA and to the State of New Jersey by July 1, 2004.

26. Respondent submitted a Form R to the EPA for processing approximately92,427,477 pounds of copper compounds for calendar year 2003 on February 2, 2007. The Form R was greater than one year late.

27. Respondent was required to submit a complete and correct Form R for copper compounds for calendar year 2004 to the Administrator of EPA and to the State of New Jersey by July 1, 2005.

28. Respondent submitted a Form R to the EPA for processing approximately78,770,594 pounds of copper compounds for calendar year 2004 on January 31, 2007. The Form R was greater than one year late.

29. Respondent was required to submit a complete and correct Form R for copper compounds for calendar year 2005 to the Administrator of EPA and to the State of New Jersey by July 1, 2006.

30. Respondent submitted a Form R to the EPA for processing approximately 67,154,233 pounds of copper compounds for calendar year 2005 on September 20, 2006. The Form R was 81 days late.

31. Respondent failed to submit, in a timely manner, a complete and correct Form R for copper compounds for each of calendar years 2002, 2003, 2004 and 2005 to the Administrator of EPA and the State of New Jersey.

32. Each of Respondent's failures to submit, in a timely manner, a Form R for lead compounds for calendar years 2002, 2003, 2004 and 2005 constitutes a failure to comply with Section 313 of EPCRA (42 U.S.C. §11023) and with 40 C.F.R. Part 372.

33. Lead compounds are listed under 40 C.F.R. §§ 372.28 and 372.65.

34. The established threshold amount for purposes of reporting under 40 C.F.R. §372.30 for processing lead compounds as a listed persistent bioaccumulative toxic chemical in calendar years 2002, 2003, 2004 and 2005 was 100 pounds. [40 C.F.R. §§ 372.25 and 372.28]

35. Respondent was required to submit a complete and correct Form R for lead compounds for calendar year 2002 to the Administrator of EPA and to the State of New Jersey by July 1, 2003.

36. Respondent submitted a Form R to the EPA for processing approximately 367,494 pounds of lead compounds for calendar year 2002 on February 2, 2007. The Form R was greater than one year late.

37. Respondent was required to submit a complete and correct Form R for lead compounds for calendar year 2003 to the Administrator of EPA and to the State of New Jersey by July 1, 2004.

38. Respondent submitted a Form R to the EPA for processing approximately 431,303 pounds of lead compounds for calendar year 2003 on February 2, 2007. The Form R was greater than one year late.

39. Respondent was required to submit a complete and correct Form R for lead compounds for calendar year 2004 to the Administrator of EPA and to the State of New Jersey by July 1, 2005.

40. Respondent submitted a Form R to the EPA for processing approximately 361,440 pounds of lead compounds for calendar year 2004 on January 31, 2007. The Form R was greater than one year late.

41. Respondent was required to submit a complete and correct Form R for lead compounds for calendar year 2005 to the Administrator of EPA and to the State of New Jersey by July 1, 2006.

42. Respondent submitted a Form R to the EPA for processing approximately 309,221 pounds of lead compounds for calendar year 2005 on September 20, 2006. The Form R was 81 days late.

43. Respondent failed to submit, in a timely manner, a complete and correct Form R for lead compounds for each of calendar years 2002, 2003, 2004 and 2005 to the Administrator of EPA and the State of New Jersey.

44. Each of Respondent's failures to submit, in a timely manner, a Form R for lead compounds for calendar years 2002, 2003, 2004 and 2005 constitutes a failure to comply with Section 313 of EPCRA (42 U.S.C. §11023) and with 40 C.F.R. Part 372.

# TERMS OF CONSENT AGREEMENT

Based on the foregoing, and pursuant to Section 325(c) of EPCRA, and in accordance with the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Etc., 40 C.F.R. §22.18 (hereinafter, "Consolidated Rules"), it is hereby agreed by and between the parties, and Respondent voluntarily and knowingly agrees as follows:

1. Respondent certifies herein that any and all EPA Toxic Chemical Release Inventory Forms submitted for the above-described violations comply with the requirements of Section 313 of EPCRA and the regulations set forth at 40 C.F.R. Part 372.

For the purpose of this proceeding, Respondent: (a) admits the jurisdictional allegations of this Consent Agreement as applied to the facility as set forth in paragraphs 1 thru
 9, inclusive; and (b) neither admits nor denies the specific factual allegations contained in the Consent Agreement and the Findings of Fact and Conclusions of Law section above.

3. Respondent shall pay by cashier's or certified check, a civil penalty totaling **NINETY EIGHT THOUSAND DOLLARS (\$98,000).** Such payment shall be made by cashier's or certified check or by Electronic Fund Transfer (EFT). If the payment is made by

check, then the check shall be made payable to the **"Treasurer, United States of America,"** and shall be mailed to:

The check shall be identified with a notation thereon listing the following: IN THE MATTER

OF NEW JERSEY, INC.** and shall bear thereon the **Docket Number EPCRA-02-2009-4101.** Payment must be <u>received</u> at the above address on or before 45 calendar days after the date of signature of the Final Order at the end of this document (the date by which payment must be received shall hereafter be referred to as the "due date"). If Respondent chooses to make the payment by EFT, then Respondent shall provide the following information to its remitter bank:

Such EFT must be received on or before 45 calendar days after the Effective Date of this CAFO. Whether the payment is made by check or by EFT, the Respondent shall promptly thereafter furnish reasonable proof that such payment has been made to both:

a. Failure to pay the penalty in full according to the above provisions will result in the referral of this matter to the U.S. Department of Justice for collection.

b. Further, if payment is not received on or before the due date, interest will be assessed, at the annual rate established by the Secretary of the Treasury pursuant to 31 U.S.C. §3717, on the overdue amount from the due date through the date of payment. In addition, a late payment handling charge of \$15.00 will be assessed for each 30 day period (or any portion thereof) following the due date in which the balance remains unpaid.

c. A 6% per annum penalty also will be applied on any principal amount not paid within 90 days of the due date.

4. This Consent Agreement is being voluntarily and knowingly entered into by the parties in full and final settlement of all civil liabilities under the Emergency Planning and Community Right-to-Know Act of 1986 (42 U.S.C. §11001 et seq.) and the regulations promulgated thereunder, 40 C.F.R. Part 372, that attach or might have attached as a result of the assertions contained in the "Findings of Fact" section, above, and the allegations contained in the "Conclusions of Law" section, above.

5. Respondent explicitly and knowingly consents to the assessment of the civil penalty as set forth in this Consent Agreement and agrees to pay the penalty in accordance with the terms of this Consent Agreement.

6. Colonial Wire & Cable Co. of New Jersey, Inc. has read the Consent Agreement, understands its terms, and voluntarily consents to its issuance and to abide by its terms and conditions, including payment of the full amount of the civil penalty in accordance with the terms set forth above. Respondent consents to the issuance of the accompanying Final Order. Respondent agrees that all terms of settlement are set forth herein.

7. Respondent waives any right it may have pursuant to 40 C.F.R. § 22.08 to be present during discussions with or to be served with and to reply to any memorandum or communication addressed to the Regional Administrator or the Deputy Regional Administrator where the purpose of such discussion, memorandum, or communication is to discuss a proposed settlement of this matter or to recommend that such official accept this Consent Agreement and issue the attached Final Order.

8. This Consent Agreement and Final Order does not waive, extinguish, or otherwise affect respondent's obligation to comply with all applicable provisions of EPCRA and the regulations promulgated thereunder.

9. Each undersigned signatory to this Consent Agreement certifies that he or she is duly and fully authorized to enter into and ratify this Consent Agreement and all the terms and conditions set forth in this Consent Agreement.

10. Each party hereto agrees to bear its own costs and fees in this matter.

11. Respondent consents to service upon Respondent by a copy of this Consent Agreement and Final Order by an EPA employee other than the Regional Hearing Clerk.
