Dear Mr. Jarvis:

This is the third letter notifying the Sand Creek Trading Post LLC (Trading Post) of noncompliance with the Administrative Order (Order) issued July 25, 2011, by the U.S. Environmental Protection Agency (EPA) under the Safe Drinking Water Act (SDWA), 42 U.S.C. Section 300F et seq.

Our records indicate that the Trading Post is again in violation of the Order. Among other things, the Order included the following requirement (summarized from item 12 on page 2 of the Order in which the Trading Post is named Respondent):

1. Respondent shall monitor the system's water quarterly for total coliform bacteria and, in the event of any result that is positive for total coliform, conduct repeat and annual routine monitoring, as required by 40 C.F.R. § 141.21. Respondent shall report analytical results to the EPA within the first 10 days following the month in which sample results were received, as required by 40 C.F.R. § 141.31(a). Respondent shall report any violation of the total coliform monitoring requirements to EPA within 10 days after discovering the violation, as required by 40 C.F.R. § 141.21(g)(2).

The Trading Post failed to monitor the system's water for total coliform during the 1<sup>st</sup> quarter (January – March) of 2015 and did not report the noncompliance to the EPA.

The EPA is considering additional enforcement action as a result of the Trading Post's non-compliance with the Order. Violating an administrative order may lead to (1) a penalty of up to \$37,500 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
