Dear Mr. Woodward:

This letter is an addendum to the Emergency Administrative Order (Order) issued on January 7, 2016, to the Warm Springs Water District (District), as owner and/or operator of the Warm Springs Water District Public Water System (System).

Paragraph 27 of the Order required the District to submit a plan and schedule to the EPA for actions that have been taken or will be taken to ensure that there is no future loss of pressure to the system. On January 26, 2016, a plan and schedule was submitted by you, Mr. Woodward, on behalf of the District. This Addendum constitutes the EPA's written approval of the schedule for replacement of the well pump and disinfection, flushing, and monitoring of the storage tank and distribution system, pursuant to paragraph 27 of the Order.

The Order is hereby amended to include the deadlines in the following table. These deadlines are an enforceable part of the Order. Any noncompliance with the deadlines will be subject to the same penalties described in the Order.

Contacted well service crew and arranged for well crew to pull pump/motor.	January 8, 2016
Board meeting to discuss action plan. Decision to replace failed motor with retired motor from pump removed from service in 2010.	January 11, 2016
Failed pump pulled. Motor failure confirmed. Retired motor and pump assembled and tested by running a trial at the surface.	January 12, 2016
Retired pump/motor installed. Retired pump tested under pressure.	January 13, 2016
Storage tank filled to more than 50% capacity.	January 15, 2016
Storage tank isolated and drained in preparation for disinfection.	January 17, 2016
Storage tank refilled and disinfected with hypochlorite water.	January 20, 2016
Distribution lines flushed and disinfected. Tested free chlorine during flushing.	January 21, 2016

Beginning January 25, 2016, collect daily and weekly total coliform, E. coli and	Until notified by the
chlorine residual monitoring and testing according to Order. Submit results to	EPA that daily and
the EPA.	weekly sampling may
	be discontinued.

Pursuant to paragraph 2 of the Order, the EPA is authorized to seek penalties if these deadlines are not met. If the District has a reasonable basis to believe it may be unable to meet any deadline in the schedule, it shall notify the EPA well in advance of the scheduled deadline to request an extension. The EPA may, in its discretion, consider granting an extension. In addition, the EPA recommends that the new pump, ordered by the District then received following installation of the retired pump, be kept on site as a backup pump.
