JOINT MOTION FOR EXTENSION OF TIME TO FILE PRE-HEARING EXCHANGES

A pre-hearing Order was issued in this matter on September 18, 2008, which set forth a schedule for, *inter alia*, the parties' pre-hearing exchanges. On November 19, 2008, the parties submitted a Joint Motion for Extension of Time, requesting a 90 day extension of the filing schedule, to allow time to negotiate the terms of a Consent Agreement and Final Order. On November 20, 2008, this Court granted that Order, and the pre-hearing exchange filing deadline for all parties was set at February 27, 2009.

Under this Joint Motion for Extension of Time to File Pre-Hearing Exchanges, the parties hereby request an additional 30 day extension of the above-referenced filing deadline. The parties have worked diligently during the 90 day extension period to complete a document that accommodates the terms of their agreement. There are complexities present here by the nature of the Respondents and the policies that the parties seek to address in the settlement that have presented unique challenges in the experience of counsel. The parties are currently documenting resolution of a very small number of remaining issues and will work to have a signed settlement agreement to file upon the expiration of the requested extension. The parties wish to avoid
