**JOINT MOTION TO EXTEND TIME FOR CONDUCT OF HEARING**

Respondent Parker Solvents Company, Inc., received on March 30, 2021, the U.S. Environmental Protection Agency's ("EPA") Initial Administrative Order in this matter. On April 21, 2021, EPA received Respondent's Response to Initial Administrative Order and Request for Hearing. Respondent and EPA (the "Parties") recognize that in accordance with 40 C.F.R. 24.14(a), the Presiding Officer shall establish a scheduling order and a hearing shall be scheduled within 45 days of the order setting the schedule. However, the Parties wish to conduct settlement negotiations regarding an Administrative Order on Consent. Accordingly, the Parties jointly request a 60-day extension of time for the conduct of the hearing pending the establishment of a scheduling order to provide a period for good faith settlement negotiations.
