**ORDER GRANTING REQUEST FOR EXTENSION OF TIME
TO FILE REBUTTAL PREHEARING EXCHANGE**

By Order dated November 5, 2009, Complainant was directed to file its initial prehearing exchange on November 30, 2009, Respondent was directed to file its prehearing exchange on December 21, and Complainant was directed to file its rebuttal prehearing exchange on December 31, 2009. Complainant filed its initial Prehearing Exchange. On December 4, 2009 Complainant filed a Request for Extension, seeking an extension of the due date to January 15, 2010 for its rebuttal prehearing exchange, on the basis of holiday season schedules of EPA staff.

Accordingly, Complainant shall file its rebuttal prehearing exchange on or before **January 15, 2010**.




