### EXPEDITED SETTLEMENT AGREEMENT AND FINAL ORDER

- The U.S. Environmental Protection Agency, Region 6 ("EPA") is authorized to enter into this Expedited Settlement Agreement ("Agreement") pursuant to Section 3008 of the Resource Conservation and Recovery Act ("RCRA"), 42 U.S.C. § 6928 and 40 C.F.R. § 22.13(b).
- By copy of this letter, EPA is providing the state of Texas with notice of the referenced violations of Subtitle C of RCRA as required by Section 3008(a)(2), 42 U.S.C. § 6928(a)(2).
- 3. P.C. Pfeiffer Co., Inc. ("P.C. Pfeiffer" or "Respondent") is the owner or operator of the facility at 1255 Main Street, Beaumont, Texas 77701 (the "Facility"). EPA conducted a Compliance Inspection at the Facility on November 4, 2024. EPA alleges that Respondent violated the following requirements of the RCRA and the EPA approved and authorized Texas hazardous waste management programs:
  - I. Failure to Meet the Standard for Hazardous Waste Determinations
    Pursuant to 30 TEX.ADMIN.CODE § 335.504, [40 C.F.R. § 262.11], A person who generates a solid waste, as defined in 40 C.F.R. § 261.2, must make an accurate determination as to whether that waste is a hazardous waste in order to ensure

wastes are properly managed according to applicable RCRA regulations. On November 4, 2024, several containers of various sizes containing unidentified wastes were managed on-site without proper hazardous waste determinations, in violation of 40 C.F.R § 262.11.

#### II. Failure to Meet Standards for Used Oil Generators

- a. Response to Releases of Used Oil

  Pursuant to 30 TEX.ADMIN.CODE § 324.15, [40 C.F.R. § 279.22(d)], Upon

  detection of a release of used oil to the environment that is not subject to

  requirements of part 280, Subpart F of this chapter and which has occurred after

  the effective date of the recycled used oil management program in effect in the

  State in which the release is located, a generator must perform required cleanup

  steps. On November 4, 2024, oil stains and water with an oily sheen was

  accumulated on concrete pads draining to adjacent soil resulting in releases of

  used oil to the environment, in violation of 40 C.F.R. § 279.22(d).
- b. Labeling/Marking Containers of Used Oil Pursuant to 30 TEX.ADMIN.CODE § 324.6, [40 C.F.R. § 279.22(c)(1)], Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil." On November 4, 2024, containers storing used oil filters were not drained by one of the methods in 40 C.F.R. § 261.4(b)(13), therefore, the containers must be labeled or marked clearly with the words "Used Oil", in violation of 40 C.F.R. § 279.22(c)(1).
- EPA and Respondent agree that settlement of this matter for a civil penalty of \$3,750 is in the public interest.

- 5. In signing this Agreement, Respondent: (1) admits that Respondent is subject to RCRA and its implementing regulations; (2) admits that EPA has jurisdiction over Respondent and Respondent's conduct as alleged herein; (3) neither admits nor denies the factual allegations contained herein; (4) consents to the assessment of this penalty; (5) waives the opportunity for a hearing to contest any issue of fact or law set forth herein; (6) waives its right to appeal the Final Order accompanying this Agreement pursuant to Section 3008(b) of RCRA, 42 U.S.C. § 6928(b); and (7) consents to electronic service of the filed ESA.
- 6. Within thirty (30) calendar days of the effective date of this Agreement, Respondent must pay the civil penalty of \$3,750 using any method provided on the following website:

  https://www.epa.gov/financial/makepayment. Such payment shall identify Respondent by name and include the docket number assigned to this Agreement by the Regional Hearing Clerk.
- 7. Within 24 hours of payment, email proof of payment (e.g., a copy of the check, confirmation of credit card or debit card payment, or confirmation of wire or automated clearinghouse transfer, and any other information required to demonstrate that payment has been made according to EPA requirements), including Respondent's name, complete address, and docket number to the following:

- No portion of the civil penalty or interest paid by Respondent pursuant to the
  requirements of this Expedited Settlement and Final Order shall be claimed by Respondent as a
  deduction for federal, state or local income tax purposes.
- 9. By signing this Agreement, Respondent waives any rights or defenses that Respondent has or may have for this matter to be resolved in federal court, including but not limited to any right to a jury trial, and waives any right to challenge the lawfulness of the final order accompanying the Agreement.
- 10. By its signature below Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that the alleged violations have been corrected, and Respondent has submitted true and accurate documentation of such correction.
- 11. The undersigned representative of Respondent certifies that he or she is fully authorized to enter the terms and conditions of this Expedited Settlement Agreement and Final Order and to execute and legally bind Respondent to it. Upon the effective date of this Agreement, payment of the civil penalty shall constitute full settlement of the civil claims alleged herein.
- 12. Full payment of the civil penalty shall only resolve Respondent's liability for federal civil penalties for the violations alleged herein. EPA reserves all of its rights to take an enforcement action for any other past, present, or future violations by Respondent of RCRA, any other federal statute or regulation, or this Agreement.
  - 13. Each party shall bear its own costs and fees, if any.
  - 14. This Agreement is binding on the parties signing below, and in accordance with 40 C.F.R.

assigns) obligation to comply with all applicable federal, state, and local statutes and

regulations, including the regulations that were the subject of this action.
