Following is a report on items that were found to be out of compliance with the EPA and there origins as was found recently through inspection of the records that were maintained in history on the RJ Pro-Link tank monitor located at Belcourt ND.

I arrived at this site a few years ago and found underground cables and wires that were broke due to rain and corrosion from the elements. This was in 2004.

We reinstalled new cables and controls to continue to monitor the lines and tanks.

We have the majority of those records starting in Dec. 04

These tests were passing through July of 2005.

After July of 05 I have no records as to what tests passed and what failed.

It appears that the power was shut-off to the system and no further tests were being maintained.

Quam Petroleum was contacted in May of 2007 to make a trip to investigate why the tank monitor was not working properly. I arrived and found wiring unhooked and the different apertures to the system was unhooked and not working at all. These items included modems, power supplies, transducer wiring etc.

While on site we totally removed the system and reinstalled on southeast wall. I reconnected new wiring and pressure sensors to start up system.

Once I left, the system appears to have run the tests for about 3 weeks and then no records until about Feb 08.

United c store management contacted me to inspect system again in Feb. 08.

I arrived and pulled the records again. Upon inspection of records there were no tests even registering. It appears that the power was shutoff during the evening and the pressure line transducers were unhooked to pump with out registrating on the monitor. I hooked the lines up and reset the lines and tanks.

I have called up the c-store on a bi-monthly basis to pull the records.

Since Feb 08 all monthly tanks and lines have passed the .02 for tanks and the .01 for lines.

I was contacted in May to do a cathodic protection test on the tanks and lines.

The tanks pass the -.850 mv test. The two lines are slightly lower than the -.850 mv test.

It appears that the conduit is partially grounding out the anodes.

We were asked to install pipe collars to separate the conduit from the piping. This is set up to do this fall as time allows.

After going over this information on the records of this site, There is no possible way that this equipment could be faulty due to equipment failure.

There was some forms of tampering that took place and where it originated I really can not say.

As of present there system is working properly and continues to maintain this sites EPA compliance.


Since 2004 there is ample proof that this UST system is working properly.
