Enclosed please find a copy of the Effective and Final Expedited Settlement Agreement (“ESA”) entered as part of the Consent Agreement and Final Order (“CA/FO”) issued to Crowley Caribbean Services, LLC (“Respondent”) concerning its marine cargo terminal located at 170-3,170-4(A) and 170 Remainder, Crown Bay, St. Thomas, Virgin Islands. This letter serves as a notification that the ESA has been approved and finalized by the EPA (SO ORDERED). Please note that this ESA settles any civil penalties claim against Respondent for the Clean Water Act violations cited in the CA/FO. Within ten (10) calendar days from receipt of this letter by electronic mail, please send a check for the amount of TEN THOUSAND DOLLARS (\$10,000) to the “Treasurer, United States of America” as indicated in the “Expedited Settlement Agreement Civil Penalty Payment Instructions” enclosed.

The payment for the penalty amount must be in the form of a bank, cashiers, or certified check payable to the "Treasurer, United States of America" with EPA’s Docket Number (CWA-02-2021-3355) of the ESA written on the check.
