The United States Environmental Protection Agency (EPA) hereby notifies you that the Expedited Settlement Agreement has been executed by both parties and is binding on EPA and you. Upon receipt of your assessed penalty of \$3,000.00, EPA will take no further action against you for the violations cited in the Settlement Agreement. Your copy of the executed agreement is enclosed.

You must submit your payment within seven (7) days of your receipt of this letter by either electronic funds transfer, certified or cashiers check made payable to "Environmental Protection Agency." The check and a letter accompanying the check shall reference the name of the responsible party (Oil Spill Liability Trust Fund -311, Lone Mountain Processing, Inc.) and the EPA docket number CWA-04-2008-5012, and shall be sent depending upon your preferred method of payment identified in Enclosure A.

(Respondent) discharged an a hearing or appeal pursuant to Section 311 of the Act, and estimated 1,000 gallons of oil in violation of Section consents to EPA's approval of the Expedited Snill 311(b)(3) of the Clean Water Act (the Act), as noted on the Settlement Agreement without further notice. stached ALLEGED CIVIL VIOLATION (Form), which is hereby incorporated by reference.

EPA finds the Respondent's conduct is subject to the discharge prohibition of Section 311(b)(3) of the Act, as described in that statute and further described by 40 CFR. § 110.3. The Respondent admits being subject to Section 3] I(b)(3) and that EPA has jurisdiction over the Respondent and the Respondent's conduct as described in the Form. Respondent does not contest the Allegations in the Form, and waives any objections it may have to EPA's jurisdiction.

EPA is authorized to enter into this Expedited Spill Settlement Agreement under the authority vested in the Administrator of EPA by Section 311(b)(6)(B)(i) of the Act, 33 U.S.C. §1321(b)(6)(B)(i), as amended by the Oil Settlement Agreement as presented within 30 days of the Pollution Act of 1990, and by 40 CFR §22.13(b). ALLEGED CIVIL VIOLATION - DOCKET NO. CWA-04-2008-5012

1. Lone Mountain Processing, Inc., Respondent, is a corporation organized under the laws of Virginia with a place of business located at P/O/Drawer C, St. Charles, Virginia 24282. The Respondent is a person within the meaning of Section 311(a)(7) of the Clean Water Act, 33 U.S.C. § 1321(a)(7) (Act).

2. Respondent is the owner of an onshore facility within the meaning of Section 311(a)(10) of the Act, 33 U.S.C. § 1321(a)(10), which is a diesel fuel tank located at or near LMPI's Days Branch Transfer Facility in Harlan County, Kentucky ("facility").

3. Section 311(b)(3) of the Act prohibits the discharge of oil into or upon the navigable waters of the United States or adjoining shorelines in such quantities that have been determined may be harmful to the public health or welfare or environment of the United States.

4. For purposes of Section 311(b)(3) and (b)(4) of the Act, 33 U.S.C. § 1321(b)(3) and (b)(4), discharges of oil into or upon the navigable waters of the United States in such quantities that have been determined may be harmful to the public health or welfare or environment of the United States are defined in 40 C.F.R. § 110.3 to include discharges of oil that (1) violate applicable water quality standards or, (2) cause a film or a sheen upon or discoloration of the surface of the water or adjoining shorelines or, (3) cause a sludge or emulsion to be deposited beneath the surface of the water or upon the adjoining shorelines.

5. On March 17, 2008, Respondent discharged an estimated 1,000 gallons of oil as defined in Section 311(a)(1) of the Act, 33 U.S.C. § 1321(a)(1), and 40 C.F.R. § 110.1, from its facility, some of which reached into or upon the Clover Fork of the Cumberland River which discharges into the Cumberland River and adjoining shorelines.

6. The Clover Fork of the Cumberland River is a "navigable water of the United States" subject to the jurisdiction of Section 311 of the Act as defined in Section 502(7) of the Act, 33 U.S.C. § 1362(7), and 40 C.F.R. § 110.1.

7. Respondent's March 17, 2008 discharge of oil from its facility caused a sheen upon or discoloration of the surface or the adjoining shoreline of the Clover Fork of the Cumberland River or caused a sludge or emulsion to be deposited beneath the surface, and therefore, was in a quantity that has been determined may be harmful under 40 C.F.R. § 110.3. Act. Pursuant to Section 311(b)(6)(B)(i) of the Act, and 40 C.F.R. § 19.4, the Respondent is liable for civil penalties of up to \$11,000 per violation, up to a maximum of \$32,500.
