EXPEDITED SETTLEMENT AGREEMENT

DOCKET NO: <u>CAA-04-2009-8025(b)</u>

This ESA is issued to:

Nashville Refrigerated Services 918 Arctic Drive Lebanon, TN 37090

for violating 40 CFR § 68.67, 40 CFR § 68.69, 40 CFR § 68.190 and Section 112(r)(7) of the Clean Air Act.

This Expedited Settlement Agreement (ESA) is being entered into by the United States Environmental Protection Agency (EPA), Region 4, the Director of the Air, Pesticides and Toxics Management Division (Complainant), and by Nashville Refrigerated Services (Respondent), pursuant to Section 113(a)(3) and (d) of the Clean Air Act (the "Act"), 42 U.S.C. § 7413(a)(3) and (d), and pursuant to 40 CFR § 22.13(b).

ALLEGED VIOLATIONS

Based on a compliance monitoring inspection conducted at the Respondent's facility located at 918 Arctic Drive, Lebanon, Tennessee, on October 17, 2007, EPA alleges that the Respondent violated the Act's Chemical Accident Prevention Program when Respondent did not provide evidence that:

It has updated and revalidated its process hazard analysis (PHA) at least every five years after the completion of the initial PHA to assure that its PHA is consistent with the current process as required by 40 CFR §68.67(f);

It has annually certified that its operating procedures are current and accurate as required by 40 CFR § 68.69(c); and

It reviewed, updated and submitted its Risk Management Plan (RMPlan) within five years of its previous RMPlan submittal. The Respondent's RMPlan was due for a five year update/resubmission on or before December 14, 2005. After EPA's inspection referenced above, the Respondent submitted its updated RMPlan on November 13, 2007 (postmark date). Failure to review, update and resubmit the Plan on or before its applicable due date is a violation of the Risk Management Program regulations promulgated at 40 C.F.R. § 68.190(b)(1) under Section 112(r) of the Act.

SETTLEMENT

In consideration of Respondent's size, its full compliance history, its good faith effort to comply, and other factors as justice may require, and upon consideration of the entire record the parties enter into the ESA in order to settle the violation cited above, for the total penalty amount of \$1410.

This settlement is subject to the following terms and conditions: the Respondent by signing below admits the jurisdictional allegations contained herein, neither admits nor denies the specific factual allegations contained herein, and consents to the assessment of the penalty as stated above; Respondent waives its rights to a hearing afforded by Section 113(d)(2)(A) of the Act, 42 U.S.C § 7413(d)(2)(A), and to contest the allegations contained in this ESA; and each party to this action shall bear its own costs and fees, if any.

Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that the Respondent has corrected the alleged violation listed in this ESA. Respondent shall pay a civil penalty of \$1410. Please note that payment should not be made until after Respondent receives a copy of the fully executed ESA. Within fifteen (15) days of receiving a copy of the fully executed ESA, the Respondent shall send a cashier's check or certified check (payable to the "Treasurer, United States of America") in the amount of \$1410, in payment of the full penalty amount to one of the following addresses:
