## STATUTORY AUTHORITY

1. Pursuant to the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders, and the Revocation, Termination or Suspension of Permits (Consolidated Rules of Practice or Part 22), specifically Subpart I, published at 64 Fed. Reg. 40138 (July 23, 1999) and the delegated authority of the Administrator of the U.S. Environmental Protection Agency (EPA or Complainant) under Section 1423 of the Safe Drinking Water Act (SDWA), 42 U.S.C. § 300h-2, the EPA, as Complainant, hereby enters into the following Consent Agreement and Final Order (CA/FO) with Blackhawk Energy, LLC (Respondent).
2. Section 1450(a)(1) of the SDWA, 42 U.S.C. § 300j-9(a)(1), authorizes the Administrator to prescribe such regulations as are necessary or appropriate to carry out her functions under the SDWA. These regulations are found at 40 C.F.R. Parts 124, 144, 146, 147, and 148, and set forth requirements for the Underground Injection Control (UIC) program promulgated under Part C of the SDWA, 42 U.S.C. § 300 h , et seq.
3. Injection well owners and operators are required to comply with the UIC program requirements. The Class II UIC program for the State of Kentucky is administered by the EPA. See 40 C.F.R. § 147.901(a).

## ALLEGATIONS

4. Respondent is a limited liability corporation organized under the laws of Kentucky doing business in the State of Kentucky, with a business address of P. O. Box 243, 110 West Main Cross, Greenville, Kentucky 42345.
5. Respondent is the owner and/or operator of the Class II underground injection wells that are subject to this Order (Subject Wells).

6. Each of the Subject Wells is a "facility" as that term is defined in 40 C.F.R. § 144.3.
7. The SDWA, 42 U.S.C. § 300f, et seq. and 40 C.F.R. § 144.51(a) require the permittee of a Class II underground injection well to comply with all conditions of the permit.
8. Part I, Section C, Paragraph 1(b)(i), of Respondent's permit requires the permittee to maintain a maximum injection pressure of 600 psig in accordance with 40 C.F.R. §144.28(d). During the field inspection conducted on August 7, 2012, by the EPA, the injection pressure was observed to be 910 psig for the following Subject Well as shown:

9. Therefore, you are in violation of the SDWA, 42 U.S.C. $\S 300$, et seq., 40 C.F.R. $\S 144.28(\mathrm{~d})$, and 40 C.F.R. $\S 144.51$ (a) for failure to maintain the maximum injection pressure.
10. Part I, Section C, Paragraph 2, of the EPA UIC permit requires the permittee to monthly monitor the operation of the injection well in accordance with 40 C.F.R. § 146.23(b)(2). Part I, Section D, Paragraph 2 of the EPA UIC permit requires the permittee to submit injection monitoring reports to the EPA annually in accordance with 40 C.F.R. § 146.23(c). The EPA's records for the Subject Wells show the injection monitoring reports submittals as follows:

11. Therefore, you are in violation of the SDWA, 42 U.S.C. § 300 f, et seq., 40 C.F.R. § 146.23(b)(2), and 40 C.F.R. §144.51(a) for failure to timely submit monitoring results.
12. Part I, Section C, Paragraph 2, of the EPA UIC permit requires the permittee to conduct an injection fluid analysis at least once every 12 months and whenever changes are made to the injection fluid, in accordance with 40 C.F.R. § 146.23(b)(1). Part I, Section D, Paragraph 2, of the subject permit requires the permittee to submit the results of the injection fluid analysis to the EPA annually in accordance with 40 C.F.R. § 146.23(c). The EPA's records for the Subject Well show the fluid analysis results submittal as follows:

13. Therefore, you are in violation of the SDWA, 42 U.S.C. § $300 f$, et seq., 40 C.F.R. § 146.23(b)(1), and 40 C.F.R. $\S 144.51(a)$ for failure to timely submit fluid analysis reports.
14. On April 26, 2013, Respondent participated in a show cause hearing with representatives of the EPA to discuss these alleged violations of the SDWA and the implementing regulations.

## STIPULATIONS AND FINDINGS

15. Respondent admits the jurisdictional allegations and facts and findings of violations as alleged herein. Respondent waives any right to a hearing and waives any right to appeal a final order in this matter, and consents to the issuance of a final order without further adjudication.
16. Complainant and Respondent have conferred for the purpose of settlement, pursuant to 40 C.F.R. § 22.18 and desire to resolve this matter and settle the violations described herein without resorting to a formal hearing. Therefore, without the taking of any evidence or testimony, the making of an argument or the adjudication of any issue in this matter and in accordance with 40 C.F.R. § 22.13(b), this CA/FO will simultaneously commence and conclude this matter.

## PENALTY AND INJUNCTIVE RELIEF

Based upon the foregoing findings, the parties hereby agree and consent to entry of the following Order:
17. Respondent shall pay a civil penalty of $\$ 3,500$ (three thousand, five hundred dollars), for failure to maintain a maximum injection pressure, failure to timely submit annual monitoring reports, and failure to submit injection fluid analysis results for two years, in accordance with the terms set forth below.
18. Within 60 days of receipt of a fully-executed copy of this CA/FO, Respondent shall submit a cashiers or certified check in the amount of $\$ 3,500$ (three thousand, five hundred dollars). The penalty payment as set forth shall be made payable to the Treasurer, United States of America at the following address:

20. Pursuant to Section 1423(2)(c)(7) of the SDWA, 42 U.S.C. § 300h-2(c)(7), failure by Respondent to pay the penalty assessed by this CA/FO in full by its due date may subject Respondent to a civil action in an appropriate district court to recover the amount assessed (plus costs, attorneys fees, and interest at currently prevailing rates from the date the order is effective). In such an action, the validity, amount and appropriateness of the penalty shall not be subject to review. Additionally, pursuant to 40 C.F.R. Part 13 and 31 U.S.C. § 3717 et seq., if the EPA does not receive payment of the penalty assessed by this CA/FO in full by its due date, interest shall accrue on the unpaid balance from the due date through date of payment at an annual rate equal to the rate of the current value of funds to the United States Treasury as prescribed and published by the Secretary of the Treasury. If all or part of the payment is overdue, the EPA shall assess an administrative fee of $\$ 15$ for each subsequent 30 day period. The EPA shall assess, on a monthly basis, a $6 \%$ per annum penalty on any principal amount not paid within 90 days of the due date.

## GENERAL PROVISIONS

22. The provisions of this CA/FO shall be binding upon Respondent and its officers, directors, agents, servants, employees and successors or assigns. Notice of this CA/FO shall be given to any successors in interest prior to transfer of the ownership or operational control of the facility.
23. This CA/FO does not constitute a waiver, suspension or modification of the requirements of Part C of the SDWA, 42 U.S.C. § 300 h , et seq. or any regulations promulgated there under. This CA/FO is not and shall not be interpreted to be, a permit for the injection of fluids under Section 1421 of the SDWA, 42 U.S.C. § 300h, nor shall it in any way relieve Respondent of any obligation imposed by any permit issued there under, or of Respondent's obligation to comply with any provision of the SDWA, its implementing regulations, or any other local, state or federal law. Payment of the penalty agreed to in this CA/FO shall not in any way affect the right of the Agency or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any other violations of law. Full payment of the penalty
and performance of the injunctive relief agreed to in this CA/FO resolves only Respondents liability for federal civil penalties for the violations and facts stipulated herein.
24. If any event beyond the control of Respondent, its successors or assigns, occurs which causes or may cause a delay in the achievement of any requirement of this CA/FO, Respondent shall notify the EPA orally within 4 days of the time it has knowledge of the occurrence of such event. A written report of said event shall be submitted by certified mail to the EPA within 10 days of the date Respondent received knowledge of the event. Said report shall describe the violation or failure, its cause and all attendant circumstances, and the measures taken or to be taken to prevent or minimize any such violation or failure and to comply with the pertinent requirements of this CA/FO as soon as possible, and the timetable by which those measures are proposed to be implemented.
25. The burden of proving that any violation or failure is caused by circumstances beyond the control of and without fault of Respondent and the length of the delay attributable to such circumstances shall rest with Respondent. Financial, economic, or business conditions or changes in same, unanticipated or increased costs or expenses, or problems relating to reasonably foreseeable technological infeasibility associated with the implementation of actions called for by this CA/FO, shall not relieve Respondent of any obligation imposed under the terms of this CA/FO, nor from payment of any penalty set forth in this CA/FO. The EPA will notify Respondent of its determination that certain circumstances are considered to be beyond Respondent's control and the extension of time, if any, for completion of the affected requirements. Respondent shall waive this right to any extension for failure to provide the EPA with written notice as provided herein or for failure to provide adequate proof for the cause of the delay.
26. For the purposes of state and federal income taxation, Respondent shall not be entitled to and agrees not to attempt to claim a deduction for any penalty payment made pursuant to this CA/FO. Any attempt to deduct any such penalty shall constitute a violation of this CA/FO.
27. The parties acknowledge and agree that final approval by the EPA of this CA/FO is subject to 40 C.F.R. § 22.45 (c)(4) which sets forth requirements under which a person not a party to this proceeding may petition to set aside a consent agreement and final order on the basis that material evidence was not considered.
28. Each party shall bear its own costs and attorneys fees in connection with this action.
29. This CA/FO shall become effective upon the date that it is filed with the Regional Hearing Clerk.
30. The undersigned representative of Respondent certifies that he or she is fully authorized to enter into the terms and conditions of this Consent Agreement and to execute and legally bind the Party he or she represents to this Agreement.
