CONSENT AGREEMENT

Preliminary Statement

This Consent Agreement is entered into by the Director of the Waste and Chemicals Management Division, U.S. Environmental Protection Agency - Region III ("EPA" or "Complainant") and Chemco, Inc. ("Respondent") pursuant to Section 14(a) of the Federal Insecticide, Fungicide and Rodenticide Act ("FIFRA"), *as amended*, 7 U.S.C. § 136l(a), and Sections 22.13(b) and .18(b) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits ("Consolidated Rules of Practice"), 40 C.F.R. § 22.13(b) and .18(b). This Consent Agreement and the attached Final Order (hereinafter jointly referred to as the "CAFO") resolve Complainant's civil penalty claims against the Respondent under FIFRA arising from the violation of FIFRA alleged herein.

General Provisions

1. For purposes of this proceeding only, Respondent admits the jurisdictional allegations set forth in this CAFO.
2. Except as provided in paragraph 1, above, Respondent neither admits nor denies the specific factual allegations and conclusions of law set forth in this CAFO.
3. Respondent agrees not to contest the jurisdiction of the EPA with respect to the execution of this Consent Agreement, the issuance of the attached Final Order, or the enforcement of the CAFO.
4. For the purposes of this proceeding only, Respondent hereby expressly waives any right to contest any issue of law or fact set forth in this Consent Agreement and any right to appeal the accompanying Final Order.

5. Respondent consents to the issuance of this CAFO and agrees to comply with its terms.
6. Respondent shall bear its own costs and attorney's fees.

EPA's Findings of Fact and Conclusions of Law

7. In accordance with the Consolidated Rules at Sections 22.13(b) and .18(b)(2) and (3), Complainant alleges the following findings of fact and conclusions of law:
 - a. Respondent is a "person" within the meaning of Section 2(s) of FIFRA, 7 U.S.C. § 136(s), and is subject to civil penalties pursuant to Section 14(a)(1) of FIFRA, 7 U.S.C. § 136l(a)(1).
 - b. At all times relevant to the violation alleged herein, Respondent operated a registered pesticide producing "establishment" as that term is defined by Section 2(dd) of FIFRA, 7 U.S.C. § 136(dd), located at 10135 Pin Oak Drive in Berlin, Maryland. This establishment is registered with EPA under Establishment Number 068566-MD-001.
 - c. At all times relevant to the violation alleged herein, Respondent was a "producer" as defined at Section 2(w) of FIFRA, 7 U.S.C. § 136(w), and 40 C.F.R. § 167.3.
 - d. Section 7(c)(1) of FIFRA, 7 U.S.C. § 136e(c)(1), provides, *inter alia*, that a producer operating a registered establishment is required to submit annually a pesticide production report to EPA stating the types and amounts of pesticides: (A) which the producer is currently producing; (B) which the producer has produced during the past year; and (C) which the producer has sold or distributed during the past year.
 - e. 40 C.F.R. § 167.85(d) requires that a producer operating a registered establishment submit its pesticide production report (EPA Form 3540-16) annually for the preceding calendar year on or before March 1 of each year, even if the producer has produced no pesticidal product for that reporting year.
 - f. Section 12(a)(2)(L) of FIFRA, 7 U.S.C. § 136j(a)(2)(L), provides that it is unlawful for any person who is a producer to violate any provisions of Section 7 of FIFRA, 7 U.S.C. § 136e.
 - g. Respondent was required to submit to EPA by March 1, 2007, a pesticide production report (EPA Form 3540-16) concerning its production, sales, and distribution of pesticides during calendar year 2006.
 - h. Respondent failed to submit its pesticide production report for calendar year 2006 on or before March 1, 2007.

- i. Respondent's failure to timely submit its pesticide production report for calendar year 2006 on or before March 1, 2007 constitutes a violation of Section 7 of FIFRA, 7 U.S.C. § 136e, and therefore, an unlawful act under Section 12 (a)(2)(L) of FIFRA, 7 U.S.C. § 136j(a)(2)(L).
- j. Respondent is a "distributor" subject to the assessment of a civil penalty under Section 14(a)(1) of FIFRA, 7 U.S.C. 136l(a)(1).

Settlement

8. In settlement of the above-captioned action, Respondent consents to the assessment of a civil penalty of Five Thousand Two Hundred Dollars (\$5,200.00) payable as described in paragraph 9, below. The aforesaid settlement amount is based upon Complainant's consideration of a number of factors, including, but not limited to, the statutory factors set forth in Section 14(a)(4) of FIFRA, 7 U.S.C. § 136l(a)(4), *i.e.*, the size of Respondent's business, the effect of the penalty on Respondent's ability to continue in business, and the gravity of the violation. These factors were applied to the particular facts and circumstances of this case with specific reference to *FIFRA Enforcement Response Policy ("ERP")*, dated July 2, 1990, the *FIFRA Section 7(c) Enforcement Response Policy*, dated February 10, 1986, 40 C.F.R. Part 19, and the *Modifications to EPA Penalty Policies to Implement the Civil Monetary Penalty Inflation Adjustment Rule (Pursuant to the Debt Collection Improvement Act of 1996, Effective October 1, 2004)*, dated September 21, 2004.
9. Pursuant to this Consent Agreement, the Respondent's Five Thousand Two Hundred Dollar (\$ 5,200.00) civil penalty shall become due and payable immediately upon Respondent's receipt of a true and correct copy of the CAFO; however, Respondent may pay such civil penalty amount, and an interest assessment of five percent (5%) per annum on the outstanding principal, in six installment payments, in the following amounts and according to the following schedule:
 - 1st Payment - The deadline for the first payment, in the amount of Eight Hundred Sixty Six Dollars and Sixty Six Cents (\$ 866.66), is thirty days after the CAFO is mailed or hand-delivered to the Respondent;
 - 2nd Payment- The deadline for the second payment, in the amount of Eight Hundred Eighty Four Dollars and Forty Seven Cents (\$ 884.47), which consists of \$ 866.66 in principle and \$ 17.81 in accrued interest, is sixty days after the CAFO is mailed or hand-delivered to the Respondent;
 - 3rd Payment- The deadline for the third payment, in the amount of Eight Hundred Eighty Dollars and Ninety One Cents (\$ 880.91), which consists of \$ 866.66 in principle and \$ 14.25 in accrued interest, is ninety days after the CAFO is mailed or hand-delivered to the Respondent;

- 4th Payment- The deadline for the fourth payment, in the amount of Eight Hundred Seventy Seven Dollars and Thirty Five Cents (\$ 877.35), which consists of \$ 866.66 in principle and \$ 10.69 in accrued interest, is one hundred and twenty days after the CAFO is mailed or hand-delivered to the Respondent;
- 5th Payment The deadline for the fifth payment, in the amount of Eight Hundred Seventy Three Dollars and Seventy Eight Cents (\$ 873.78), which consists of \$ 866.66 in principle and \$ 7.12 in accrued interest, is one hundred and fifty days after the CAFO is mailed or hand-delivered to the Respondent;
- 6th Payment The deadline for the sixth payment, in the amount of Eight Hundred Seventy Dollars and Twenty Six Cents (\$ 870.26), which consists of \$ 866.70 in principle and \$3.56 in accrued interest, is one hundred and eighty days after the CAFO is mailed or hand-delivered to the Respondent.

Payment in accordance with the above schedule results in the Respondent's *total payment of Five Thousand Two Hundred Fifty three Dollars and Forty Three Cents (\$ 5,253.43)*, which consists of a civil penalty in the aforesaid amount of Five Thousand Two Hundred Dollar (\$ 5,200.00) and the payment of accrued interest in the amount of Fifty Three Dollars and Forty Three Cents (\$ 53.43).

10. Notwithstanding Respondent's agreement to pay the civil penalty in accordance with the installment payment provisions of Paragraph 9, immediately above, Respondent may pay the entire Five Thousand Two Hundred Dollar (\$ 5,200.00) civil penalty within **thirty (30) calendar days** after the date on which a copy of this CAFO is mailed or hand-delivered to Respondent and, thereby, avoid the incurrence and payment of interest pursuant to 40 C.F.R. § 13.11(a)(1), as described in Paragraphs' 13 and 14, below.
11. If Respondent elects to pay the civil penalty in accordance with the installment payment procedure described in Paragraph 9, above, but fails to make any installment payment in accordance with the requirements and schedule set forth in Paragraph 9, the entire unpaid balance of the penalty and all accrued interest shall become due immediately upon such failure, and Respondent immediately shall pay the entire remaining principal balance of the civil penalty along with any interest that has accrued up to the time of such payment. In addition, Respondent shall be liable for and shall pay administrative handling charges and late payment penalty charges as described in Paragraphs 15 and 16 below, in the event of any such failure or default.
12. Payment of the penalty, or each installment of the penalty, required under the terms of this Consent Agreement, shall be made as follows:

- e. Online payments can be made at WWW.PAY.GOV by entering “sfo 1.1” in the search field, and opening the form and completing the required fields.

Each payment shall also reference the above case caption and docket number, Docket No. FIFRA-03-2008-0319. At the same time that any payment is made, Respondent shall mail copies of any corresponding check, or provide written notification confirming any electronic wire transfer, automated clearinghouse or online payment to Lydia A. Guy, Regional Hearing Clerk (3RC00), U.S. EPA, Region III, 1650 Arch Street, Philadelphia, Pennsylvania 19103-2029 and to Stephen Forostiak (3WC32), Waste and Chemicals Management Division, U.S. Environmental Protection Agency, Region III, 1650 Arch Street, Philadelphia, Pennsylvania 19103-2029.

13. Pursuant to 31 U.S.C. § 3717 and 40 C.F.R. § 13.11, EPA is entitled to assess interest, administrative costs and late payment penalties on outstanding debts owed to the United States and also to assess a charge to cover the costs of processing and handling a delinquent claim, as more fully described below.
14. In accordance with 40 C.F.R. § 13.11(a), interest on the civil penalty assessed in this CAFO begins to accrue on the date that a copy of this Consent Agreement and the accompanying Final Order are mailed or hand-delivered to Respondent. However, EPA will not seek to recover interest on any amount of the civil penalty that is paid within thirty (30) calendar days after the date on which such interest begins to accrue. Interest will be assessed at the rate of the United States Treasury tax and loan rate in accordance with 40 C.F.R. § 13.11(a).
15. The cost of the Agency's administrative handling of overdue debts will be charged and assessed monthly throughout the period the debt is overdue. 40 C.F.R. § 13.11(b). Pursuant to Appendix 2 of EPA's *Resources Management Directives - Cash Management*, Chapter 9, EPA will assess a \$15.00 administrative handling charge for administrative costs on unpaid penalties for the first thirty (30) day period after the payment is due and an additional \$15.00 for each subsequent thirty (30) days the penalty remains unpaid.
16. A late payment penalty of six percent (6%) per year will be assessed monthly on any portion of the civil penalty which remains delinquent more than ninety (90) calendar days. 40 C.F.R. § 13.11(c). Should assessment of the penalty charge on the debt be required, it shall accrue from the first day payment is delinquent. 31 C.F.R. § 901.9(d).
17. Respondent agrees not to deduct for civil taxation purposes the civil penalty paid pursuant to this CAFO.

Certification

18. Respondent certifies by its signature herein that it is currently in compliance with all applicable requirements of FIFRA § 7, 7 U.S.C. § 136e.

Other Applicable Laws

19. Nothing in this CAFO shall relieve Respondent of its obligation to comply with all applicable Federal, State, and local laws and regulations.

Reservation of Rights

20. This CAFO resolves only EPA's civil claims for penalties for the specific violation alleged in this Consent Agreement. EPA reserves the right to commence action against any person, including Respondent, in response to any condition which EPA determines may present an imminent and substantial endangerment to the public health, public welfare, or the environment. In addition, this settlement is subject to all limitations on the scope of resolution and to the reservation of rights set forth in Section 22.18(c) of the Consolidated Rules of Practice. Further, EPA reserves any rights and remedies available to it under FIFRA, the regulations promulgated there under, and any other Federal laws or regulations for which EPA has jurisdiction, to enforce the provisions of this CAFO, following its filing with the Regional Hearing Clerk.

Full and Final Satisfaction

21. Payment of the penalty specified in paragraph 8, above, in accordance with the terms of this CAFO, shall constitute full and final satisfaction of all civil claims for penalties which Complainant may have under Section 14(a) of FIFRA, 7 U.S.C. § 136l(a), for the specific violation alleged in this CAFO. Compliance with this CAFO shall not be a defense to any action commenced at any time for any other violation of the Federal laws and regulations administered by EPA.

Parties Bound

22. This CAFO shall apply to and be binding upon the EPA, Respondent, and the officers, directors, successors, and assigns of Respondent. By his or her signature below, the person signing this Consent Agreement on behalf of Respondent is acknowledging that he or she is fully authorized by Respondent to execute this Consent Agreement and to legally bind Respondent to the terms and conditions of this CAFO.

Effective Date

23. The effective date of this CAFO is the date on which the Final Order, signed by the Regional Administrator of EPA -- Region III, or his designee, the Regional Judicial Officer, is filed with the Regional Hearing Clerk pursuant to the Consolidated Rules of Practice.

Entire Agreement

24. This CAFO constitutes the entire agreement and understanding of the Parties concerning settlement of the above-captioned action and there are no representations, warranties, covenants, terms, or conditions agreed upon between the Parties other than those expressed herein.
