CONSENT AGREEMENT AND FINAL ORDER

I. Nature of the Action

- 1. This is a civil penalty proceeding pursuant to Section 113(d) of the Clean Air Act (CAA), 42 U.S.C. § 7413(d), and pursuant to the Consolidated Rules of Practice Governing Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders and the Revocation, Termination or Suspension of Permits (Consolidated Rules), published in 40 CFR Part 22. Complainant is the Director of the Air, Pesticides and Toxics Management Division, Region 4, United States Environmental Protection Agency. Respondent is Wise Alloys, LLC (hereinafter, "Respondent").
- 2. The authority to take action under Section 113(d) of the CAA, 42 U.S.C. § 7413(d), is vested in the Administrator of the EPA. The Administrator of the EPA has delegated this authority under the CAA to the Regional Administrators by the EPA Delegation 7-6-A, last updated on August 4, 1994. The Regional Administrator, Region 4, has re-delegated this authority to the Director, Air, Pesticides and Toxics Management Division. Pursuant to that delegation, the Director of the Air, Pesticides and Toxics Management Division has the authority to commence an enforcement action as the Complainant in this matter. Complainant and Respondent have conferred for the purpose of settlement pursuant to 40 CFR § 22.18, and agree to resolve this matter and settle the allegations described herein without a formal hearing. Therefore, without the taking of any evidence or testimony, the making of any argument, or the adjudication of any issue in this matter, and in accordance with 40 CFR § 22.13(b), this Consent Agreement and Final Order (CAFO) will simultaneously commence and conclude this matter.

II. Preliminary Statements

- 3. Respondent is licensed to do business in the State of Alabama.
- 4. Respondent is a "person" within the meaning of Section 302(e) of the CAA, 42 U.S.C. § 7602(e), and is therefore subject to the provisions of the CAA and the regulations promulgated thereunder.
- 5. Respondent operates a "stationary source" as that term is defined by Section 302(z) of the CAA, 42 U.S.C. § 7602(z). The Respondent's stationary source is located at 4805 Second Street, Muscle Shoals, Alabama 35661.

- 6. Section 112(r) of the CAA, 42 U.S.C. § 7412(r), addresses the prevention of releases of substances listed pursuant to Section 112(r)(3) of the CAA, 42 U.S.C. § 7412(r)(3). The purpose of this section is to prevent the accidental release of extremely hazardous substances and to minimize the consequences of such releases. Pursuant to Section 112(r)(7) of the CAA, 42 U.S.C. § 7412(r)(7), the EPA is authorized to promulgate regulations for accidental release prevention.
- 7. Pursuant to Section 112(r)(3) and 112(r)(7) of the CAA, 42 U.S.C. §§ 7412(r)(3) and 7412(r)(7), the EPA promulgated rules codified at 40 CFR Part 68, Chemical Accident Prevention Provisions. These regulations are collectively referred to as the "Risk Management Program" (RMP) and apply to an owner or operator of a stationary source that has more than a threshold quantity of a regulated substance in a covered process. Pursuant to Sections 112(r)(3) and 112(r)(5) of the CAA, 42 U.S.C. §§ 7412(r)(3) and 7412(r)(5), the list of regulated substances and threshold levels are codified at 40 CFR § 68.130.
- 8. The Respondent, at its stationary source identified in Paragraph 5 of this CAFO, had at the time of the inspection, three RMP covered processes: the Cast House Chlorine Bigas Process; High Speed Cleaning and Coating Line and Storage Tanks; and the Chrome Treatment Plant. The respective covered processes at the time of the inspection stored or otherwise used chlorine, sulfur dioxide and a flammable mixture, in an amount exceeding the applicable thresholds of 2,500, 5,000 and 10,000 pounds.
- 9. Pursuant to Section 112(r)(7)(B)(iii) of the CAA, 42 U.S.C. § 7412(r)(7)(B)(iii), and 40 CFR §§ 68.10 and 68.150, the owner or operator of a stationary source that has a regulated substance in an amount equal to or in excess of the applicable RMP threshold in a "process" as defined in 40 CFR § 68.3, must develop an RMP accidental release prevention program, and submit and register a single Risk Management Plan (Plan) with the EPA.
- 10. Respondent has submitted and registered a Plan to the EPA for the stationary source identified in Paragraph 5 of this CAFO. Respondent has also developed an RMP accidental release prevention program for the stationary source.
- 11. Based on an RMP compliance monitoring investigation initiated on August 5, 2013, the EPA alleges that the Respondent failed to adequately implement provisions of 40 CFR Part 68, and thereby violated the codified rules governing the CAA Chemical Accident Prevention Provisions, by failing to:

Estimate in the RMP, the population within a circle with its center at the point of the release and a radius determined by the distance to the endpoint as required by 40 CFR § 68.30(a);

List in the RMP, the environmental receptors within a circle with its center at the point of the release and a radius determined by the distance to the endpoint as required by 40 CFR § 68.33(a);

Document in the process safety information that equipment complies with recognized and generally accepted good engineering practices as required by 40 CFR § 68.65(d)(2);

Address operating limits in the written operating procedures as required by 40 CFR § 68.69(a)(2); and establish and implement written procedures to maintain the ongoing integrity of process equipment as required by 40 CFR § 68.73(b).

III. Consent Agreement

- 12. For the purposes of this CAFO, Respondent admits the jurisdictional allegations set out above but neither admits nor denies the factual allegations set out above.
- 13. Respondent waives any right to contest the allegations and its right to appeal the proposed final order accompanying the Consent Agreement.
- 14. Respondent consents to the assessment of and agrees to pay the civil penalty as set forth in this CAFO.
- 15. Respondent agrees to complete the Supplemental Environmental Project as set forth in this CAFO.
- 16. Respondent certifies that as of the date of execution of this CAFO, to the best of the Respondent's knowledge after a good faith inquiry, it is compliant with the applicable requirements of Section 112(r) of the CAA.
- 17. Compliance with the CAFO shall resolve the allegations of violations contained herein. This CAFO shall not otherwise affect any liability of Respondent to the United States other than as expressed herein. Neither the EPA nor Complainant waives any right to bring an enforcement action against Respondent for violation of any federal or state statute, regulation or permit, to initiate an action for imminent and substantial endangerment, or to pursue criminal enforcement.
- 18. Complainant and Respondent agree to settle this matter by their execution of this CAFO. The parties agree that the settlement of this matter is in the public interest and that this CAFO is consistent with the applicable requirements of the RMP.

IV. Final Order

- 19. Respondent agrees to pay a civil penalty of **FOUR THOUSAND NINE HUNDRED DOLLARS** (\$4,900), to be paid within thirty (30) days of the effective date of this CAFO.
- 20. Respondent shall pay the penalty by forwarding a cashier's or certified check payable to the "Treasurer, United States of America," to one of the following addresses or by electronic transfer in accordance with the following instructions:

21. At the time of payment, the Respondent shall send a separate copy of the check or the electronic wire request, and a written statement that payment has been made in accordance with this CAFO, to the following persons at the following addresses:

22. For the purposes of state and federal income taxation, Respondent shall not be entitled, and agrees not to attempt, to claim a deduction for any civil penalty payment made pursuant to this CAFO. Any attempt by Respondent to deduct any such penalty payment shall constitute a violation of this CAFO.

V. Supplemental Environmental Project

23. Respondent shall undertake and complete the following Emergency Planning and Preparedness project within 45 days of the effective date of this CAFO. Respondent shall expend no less than **EIGHTEEN THOUSAND NINE HUNDRED NINETY TWO DOLLARS** (\$18,992) for the purchase and donation of the following items to the Muscle Shoals Fire Department:

24. This CAFO shall not be construed to constitute EPA's endorsement of the equipment or technology to be purchased by Respondent in connection with the SEP undertaken pursuant to this Agreement.

25. Respondent certifies that:

- a. It is not a party to any open federal financial assistance transaction that is funding or could fund the same activity as the SEP described in paragraph 23; and
- b. It has inquired of the Muscle Shoals Fire Department whether the Muscles Shoals Fire Department is a party to an open federal financial assistance transaction that is funding or

could fund the same activity as the SEP and has been informed by the Muscles Shoals Fire Department that is not a party to such a transaction.

- 26. Respondent agrees that in order to receive credit for the SEP, it must fully and timely complete the SEP project in accordance with Paragraph 23. If Respondent does not fully and timely complete the SEP, it shall be required to pay stipulated penalties pursuant to Paragraph 27.
- 27. If Respondent fails to timely and fully complete any part of the SEP, including failure to spend the minimum amount of EIGHTEEN THOUSAND NINE HUNDRED NINETY TWO DOLLARS (\$18,992), Respondent shall pay to the United States a stipulated penalty of the difference between \$18,992 and the actual SEP expenditure.
- 28. For purposes of Paragraph 27, the determination as to whether Respondent has fully and timely completed the SEP shall be in the sole discretion of the EPA.
- 29. No later than sixty (60) calendar days after the effective date of this CAFO, Respondent shall submit to EPA a SEP Completion Report. The Report shall be sent to the Chemical Management and Emergency Planning Section, to the attention of Deanne Grant at the address provided above in Paragraph 21. The Report shall include the following:
 - (a) an affidavit from an authorized company official, attesting that the SEP has been completed or explaining in detail any failure to complete it; and
 - (b) copies of appropriate documentation, including invoice and receipts, showing a total expenditure of no less than \$18,992, was spent on the Emergency Planning and Preparedness SEP described in Paragraph 23.

Upon request, Respondent shall send EPA any additional documentation requested by EPA.

- 30. If Respondent fails to timely submit a SEP Completion Report as required by this CAFO, Respondent shall pay to the United States a stipulated penalty of \$100 for each calendar day the report is late.
- 31. Respondent shall pay any stipulated penalties that accrue under this CAFO within 15 calendar days of the receipt by Respondent of written demand from EPA for such penalties. Such penalties shall be paid in accordance with the procedures set forth above for the payment of the civil penalty.
- 32. Respondent certifies that, as of the date this CAFO is signed, it is not required to perform any part of the SEP by any federal, state or local law, regulation, permit or order, or by any agreement or grant. Respondent further certifies that, as of this date, it has not received and is not negotiating to receive, credit for any part of the SEP in any other enforcement action of any kind.

- 33. For Federal Income Tax purposes, Respondent agrees that it will neither capitalize into inventory or basis nor deduct any costs or expenditures incurred in performing the SEP.
- 34. Any public statement, oral or written, by Respondent making any reference to the SEP shall include the following language:

"This project was undertaken in connection with the settlement of an enforcement action taken by the U.S. Environmental Protection Agency for violations of Section 112(r)(7) of the Clean Air Act (CAA)."

- 35. Pursuant to 31 U.S.C. § 3717, the EPA is entitled to assess interest and penalties on debts owed to the United States and a charge to cover the cost of processing and handling a delinquent claim. Interest will therefore begin to accrue on the civil penalty from the effective date of this CAFO if the penalty is not paid by the date required. Interest will be assessed at the rate established by the Secretary of Treasury pursuant to 31 U.S.C. § 3717. A charge will be assessed to cover the costs of debt collection, including processing and handling costs and attorney fees. In addition, a penalty charge will be assessed on any portion of the debt that remains delinquent more than ninety (90) days after payment is due.
- 36. Complainant and Respondent shall bear their own costs and attorney fees in this matter.
- 37. This CAFO shall be binding upon the Respondent, its successors and assigns.
