Complainant filed the Class II Administrative Complaint against Respondent on May 30, 2023. Pueblo of Isleta filed a Motion for Leave to Intervene on June 27, 2023. Complainant filed a Motion for Extension of Time on July 5, 2023, which was granted until August 28, 2023. On August 23, 2023, Complainant filed its second Motion for Extension of Time in order to continue positive discussions with both the Respondent and Proposed Intervenor in order to potentially reach a settlement in this matter and to postpone its response to Proposed Intervenor’s Motion. On December 18, 2023, Complainant filed a third unopposed motion for extension of time to continue negotiations with all parties, which I granted until March 25, 2024. On March 20, 2024, I granted the parties’ fourth extension motion, allowing for additional time to continue negotiations until June 28, 2024.

On June 26, 2024, the parties have now requested additional time. The parties have reached a settlement in principal and are negotiating the two SEPs that will accompany the final settlement document.

It is therefore ORDERED that the request be, and hereby is, GRANTED until September 27, 2024.


