CONSENT AGREEMENT AND FINAL ORDER

I. Nature of the Action

1. This is a civil penalty proceeding pursuant to Section 16(a) of the Toxic Substances

Control Act (TSCA), 15 U.S.C. § 2615(a), and pursuant to the Consolidated Rules of

Practice Governing Administrative Assessment of Civil Penalties and the

Revocation/Termination or Suspension of Permits (Consolidated Rules), 40 C.F.R. Part

22. The authority to take action under Section 16(a) of TSCA, 15 U.S.C. § 2615(a) is

vested in the Administrator of the United States Environmental Protection Agency. The

Administrator of the EPA has delegated this authority under TSCA to the Regional

Administrator of the EPA Region 4 by the EPA Delegation 12-2-A, dated May 11, 1994.

The Regional Administrator of the EPA Region 4 has re-delegated this authority under

TSCA to the Director of the Air, Pesticides, and Toxics Management Division, by the

EPA Region 4 Delegation 12-2-A, dated January 14, 2009. In accordance with 40 C.F.R.

§ 22.3(a), the Complainant in this matter is the Director of the Air, Pesticides, and

Toxics Management Division. Respondent is Tiny's Construction, LLC, a limited

liability company doing business in the State of Tennessee.

2. Complainant and Respondent have conferred for the purpose of settlement pursuant to 40 C.F.R. § 22.18 and desire to resolve this matter and settle the allegations described herein without a formal hearing. Therefore, without the taking of any evidence or testimony, the making of any argument, or the adjudication of any issue in this matter, and in accordance with 40 C.F.R. § 22.13(b), this Consent Agreement and Final Order (CAFO) will simultaneously commence and conclude this matter.

II. Preliminary Statements

- 3. Pursuant to Sections 402 and 406 of the Toxic Substances Control Act (TSCA), 15

 U.S.C. §§ 2682 and 2686, the Administrator of the EPA promulgated Residential

 Property Renovation Rules at 40 C.F.R. Part 745, Subpart E including the PreRenovation Education Rule, the Renovation, Repair and Painting Rule, and the LeadBased Paint Activities Rule. It is a prohibited act under Section 409 of TSCA, 15 U.S.C.

 § 2689, for any person to fail or refuse to comply with any of the rules issued under 40

 C.F.R. Part 745, Subpart E.
- 4. Pursuant to 40 C.F.R. § 22.5(c)(4) the following individual is authorized to receive service for the EPA in this proceeding:

III. Specific Allegations

5. Respondent is a "renovation firm," that performs "renovation activities" for compensation as those terms are defined, respectively, by 40 C.F.R. § 745.89(a), and 40 C.F.R. § 745.81(a). Respondent performed renovation activities at residential

dwellings located at 502 Chesterfield Avenue, Nashville, Tennessee 37212; 3411 Springbrook Drive, Nashville, TN 37204; and 3407 Woodhaven Drive, Nashville, TN 37204.

6. Based on information obtained during an inspection conducted by the EPA on June 9, 2015, the EPA alleges that Respondent violated Sections 402 and 406 of TSCA and 40 C.F.R. Part 745, Subpart E as follows:

Respondent failed to provide the owner or adult occupant of the unit with the EPA approved lead hazard information pamphlet pursuant to 40 C.F.R. § 745.84 (a).

IV. Consent Agreement

- 7. For the purposes of this CAFO, Respondent admits the jurisdictional allegations set forth above and neither admits nor denies the factual allegations set forth above.
- 8. Respondent waives its right to a hearing on the allegations contained herein and its right to appeal the Final Order accompanying the Consent Agreement.
- 9. Respondent consents to the assessment of the penalty proposed by the EPA and agrees to pay the civil penalty as set forth in the Final Order section of this CAFO.
- 10. Respondent certifies that as of the date of its execution of this CAFO, it is in compliance with all relevant requirements of 40 C.F.R. § Part 745, Subpart E.
- 11. Compliance with this CAFO shall resolve the allegations of the violations contained herein. This CAFO shall not otherwise affect any liability of Respondent to the United States. Other than as expressed herein, neither the EPA nor Complainant waives any right to bring an enforcement action against Respondent for violation of any federal or state statute, regulation or permit, to initiate an action for imminent and substantial endangerment, or to pursue criminal enforcement.

V. Final Order

- 12. Respondent is assessed a civil penalty of TWO THOUSAND, EIGHT HUNDRED FORTY DOLLARS (\$2,840) which shall be paid within thirty (30) days after the effective date of this CAFO.
- 13. Respondent shall remit the penalty payment by either a cashier's or certified check made payable to the "Treasurer, United States of America."

The Respondent shall note on the face of the check the Respondent's Name and the Docket Number TSCA-04-2015-2509(b).

The penalty payment shall be sent by one of the methods below.

- 15. For the purposes of state and federal income taxation, Respondent shall not be entitled, and agrees not to attempt, to claim a deduction for any civil penalty payment pursuant to this CAFO. Any attempt by Respondent to deduct any such payments shall constitute a violation of this CAFO.
- 16. Pursuant to 31 U.S.C. § 3717, the EPA is entitled to assess interest and penalties on debts owed to the United States and a charge to cover the cost of processing and handling a delinquent claim. Interest will therefore begin to accrue on the civil penalty from the date of entry of this CAFO, if the penalty is not paid by the date required. A charge will also be assessed to cover the administrative costs, both direct and indirect, of overdue debts. In addition, under the Adequate Response Requirement of the CAFO Policy a late payment may require Formal Enforcement Procedures be employed to collect any principal amount not paid within 30 days of the due date.
- 17. Complainant and Respondent shall bear their own costs and attorney fees in this matter.
- 18. This CAFO shall be binding upon the Respondent, its successors and assigns.
- 19. Each undersigned representative of the parties to this CAFO certifies that he or she is
