Good afternoon,

Following up on two voicemail messages I've left regarding filing a notice of appearance and an answer in a CAA matter. We want to confirm that we can file the notice of appearance by email, with email service to the service recipients, in the same way as we will file the answer. Separately, the Consolidated Rules of Practice require the filing “the original and one copy of

each document to be filed[.]” 40 CFR § 22.5(a)(1). If we are filing by email, does the regional hearing clerk want us to attach two PDFs of the same document? Or is one PDF sufficient?
