follows:

1. On April 6, 2012, this Court issued an *Order on Status Report and Joint Motion Requesting Stay in the Proceedings*, pursuant to which Complainant shall file Status Reports every two weeks in order to apprise the Chief Administrative Law Judge of the progress made towards settlement.

2. On April 20, 2012, Complainant submitted the first Status Report, in which it was informed that the proposed SEP is being reviewed by Region 2 as well as the Special Litigations and Projects Division.

3. During the last two weeks following our first Status Report, Complainant has spoken with Respondent’s representative in order to explain the comments and suggestions that

have been offered in the review process. In the light of the information offered by Complainant, Respondent has expressed its intention to modify its SEP proposal. It has been agreed that Respondent will send a written proposal that will reflect such changes.

4. Complaint respectfully requests the Honorable Chief Administrative Law Judge to take notice of the status of settlement in the case of reference.

5. This Motion was discussed today, May 4, 2012, with Pedro Reyes Bibiloni, Esq., attorney for Respondent, who agreed to the filing of this motion.
