ORDER ON JOINT MOTION FOR WITNESS APPEARANCE BY VIDEOCONFERENCE

Pending before me is the parties’ Joint Motion for Witness Appearance by Videoconference (“Motion”), filed June 23, 2022.

Due to the ongoing COVID-19 pandemic, the parties ask “for accommodation to allow some or all of the sixteen (16) witnesses who provided verified written witness statements in this matter . . . to appear via videoconference” at the hearing scheduled to begin on July 6, 2022. Mot. at 1. The parties further assert that they “will take steps to ensure that each witness that provided direct testimony in support of its position is available for cross-examination by any other party” and “[e]ach witness shall be available for cross-examination during a period mutually-agreeable to all parties, or during the entirety of the scheduled hearing, as appropriate.” Mot. at 2.

The parties have asserted good cause for their request, and the Motion is **GRANTED**. OALJ staff will communicate further details to the parties regarding necessary technical logistics when they become known to the Tribunal.
