## ORDER DENYING MOTION FOR DEFAULT AND ACCEPTING PREHEARING EXCHANGE

There is currently pending a motion for a default order filed by Complainant. The basis for the motion is that the Respondent has not filed a prehearing exchange as required by the Order Setting Prehearing Procedures issued herein. The Respondent filed an opposition to the motion for default and has requested time to file the prehearing exchange and to reply to the Complainant's prehearing exchange. Moreover, no prejudice to the Complainant has been shown as a result of the Respondent's not filing the prehearing exchange on time.

Accordingly, the Respondent's prehearing exchange and reply to Complainant's prehearing exchange is accepted for filing.
