Any motion to conform the transcript to the actual testimony shall be filed on or before **May 1, 2025**. See 40 C.F.R. § 22.25. The parties may file any such motion jointly or separately.

As indicated on the record at the conclusion of the hearing, the parties may file post-hearing briefs. See 40 C.F.R. § 22.26 ("After the hearing, any party may file proposed findings of fact, conclusions of law, and a proposed order, together with briefs in support thereof."). Reply briefs may be filed if the parties deem it necessary. The post-hearing briefs shall be filed and served pursuant to the following schedule:

Complainant's Initial Post-Hearing Brief	Friday, May 16, 2025
Respondent's Initial Post-Hearing Brief	Friday, June 13, 2025
Complainant's Reply Post-Hearing Brief	Friday, June 27, 2025
Respondent's Reply Post-Hearing Brief	Friday, July 11, 2025

All briefs shall contain specific citations to the record and to any legal authorities upon which the filing party relied. If a party does not intend to file an initial or reply post-hearing brief as permitted above, the party shall notify Jennifer Almase, an Attorney-Advisor for this Tribunal, at almase.jennifer@epa.gov.
