ORDER ON RESPONDENT'S MOTION FOR EXTENSION OF TIME

On April 17, 2018, I issued a Prehearing Order that established deadlines for the parties to file prehearing exchange documents. The Agency filed its initial prehearing exchange on May 31, 2018. Respondent's deadline to file its prehearing exchange was set for June 22, 2018.

On June 20, 2018, Respondent filed what it referred to as a "Joint Motion for Extension of Time to File Respondent's Prehearing Exchange and Complainant's Rebuttal Prehearing Exchange" ("Motion"). In the Motion, Respondent asks to extend until July 13, 2018, the deadline for filing its prehearing exchange. Respondent also requests a corresponding extension for the Agency's rebuttal prehearing exchange to July 27, 2018, and states that the Agency agrees to the extensions. Respondent indicates it needs more time "[d]ue to scheduling conflicts and the unavailability of key persons for the preparation of Respondent's Prehearing Exchange." Mot. at 1.

Under the rules governing this proceeding, this Tribunal "may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative." 40 C.F.R. § 22.7(b). Respondent has shown sufficient cause for extending the remaining prehearing exchange deadlines, and it appears the Agency does not object.

Consequently, Respondent's Motion is **GRANTED**. The prehearing exchange deadlines are extended as follows:

July 13, 2018 Respondent's Prehearing Exchange

July 27, 2018 Complainant's Rebuttal Prehearing Exchange
