# ORDER SHORTENING TIME FOR RESPONSE ON COMPLAINANT'S MOTION TO ACCEPT AN AFFIDAVIT IN LIEU OF TESTIMONY

On April 8, 2022, Complainant U.S. Environmental Protection Agency, Region 10 ("Complainant") filed a Motion to Accept an Affidavit in Lieu of Oral Testimony ("Motion"). Under 40 C.F.R. §22.16(b), Respondent GreenBuild Design and Construction, LLC's ("Respondent") response to Complainant's Motion must be filed within 15 days after the motion was filed. However, the hearing in this case is scheduled to begin on May 2, 2022. Thus, to allow time for Complainant to reply to any response filed by Respondent, and to allow time for this Tribunal to consider the Motion and rule on it before the hearing begins, the deadline for Respondent to respond to the Motion shall be shortened to one week as provided by Section 22.16(b) of the Rules. See 40 C.F.R. § 22.16(b) ("The Presiding Officer . . . may set a shorter or longer time for response or reply, or make other orders concerning the disposition of motions").

Therefore, Respondent is hereby ordered to file its response to the Motion on or before April 15, 2022.
