**ORDER GRANTING UNOPPOSED MOTION FOR FURTHER EXTENSION OF
PREHEARING DEADLINES**

This proceeding was initiated on September 12, 2023, with the filing of a Complaint by Complainant, the Director of the Enforcement and Compliance Assurance Division of Region 3 of the U.S. Environmental Protection Agency (“Agency”), against Respondents Gary Powers and Angie Powers pursuant to Section 309(g) of the Clean Water Act, 33 U.S.C. § 1319(g). Respondents subsequently filed an Answer to the Complaint, in which they denied the alleged violations and disputed the Complaint’s proposed penalties. After I was designated to preside over the proceeding, I issued a Prehearing Order setting deadlines for a number of prehearing procedures, including the filing of a fully-executed Consent Agreement and Final Order (“CAFO”) if the parties achieved settlement of this matter and a prehearing exchange of information by each party if settlement was not achieved in the meantime. On December 12, 2023, I granted Complainant’s December 6, 2023, Consent Motion for Extension of Prehearing Deadlines, thereby extending the Prehearing Order’s CAFO and prehearing exchange deadlines by approximately two months. Order Granting Consent Mot. to Extend (Dec. 12, 2023).

On February 5, 2024, Complainant filed an Unopposed Motion for Further Extension of Prehearing Deadlines (“Motion”), which seeks a 28-day extension of the parties’ deadlines to file a CAFO or their prehearing exchanges. Mot. ¶ 9. The Motion represents that the parties remain engaged in settlement negotiations, that Respondents provided Complainant with certain material information on December 29, 2023, that Complainant completed its analysis of that information on February 1, 2024, and that the parties require additional time to negotiate and to reduce any settlement agreement to writing. Mot. ¶¶ 5–8.

This matter is governed by the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits (“Rules of Practice”) set forth at 40 C.F.R. Part 22. The Rules of Practice provide that I “may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative.” 40 C.F.R. § 22.7(b).

Here, the Motion was timely and shows good cause. As reflected in the Rules of Practice, Agency policy supports settlement of a proceeding without the necessity of a formal

hearing. 40 C.F.R. § 22.18(b)(1). The interests of the parties and judicial economy are well served by the parties resolving this matter informally and expeditiously. Therefore, the Motion is hereby **GRANTED**. The parties shall adhere to the following revised deadlines.

A fully-executed CAFO shall be filed with the Regional Hearing Clerk on or before **March 8, 2024**, with a courtesy copy filed with the Headquarters Hearing Clerk. Alternatively, if the parties are unable to finalize a CAFO by that date, they shall file their prehearing exchanges pursuant to the following schedule:

March 8, 2024	Complainant's Initial Prehearing Exchange
March 29, 2024	Respondents' Prehearing Exchange(s)
April 19, 2024	Complainant's Rebuttal Prehearing Exchange
