POST-HEARING SCHEDULING ORDER

As provided for in the rules governing this proceeding, the parties “may file proposed findings of fact, conclusions of law, and a proposed order, together with briefs in support thereof.” 40 C.F.R. § 22.26. Therefore, the parties shall submit post-hearing briefs in sequential order, beginning with Complainant’s initial brief, in accordance with the following schedule:

Complainant’s Initial Post-Hearing Brief:	December 14, 2018
Respondent’s Initial Post-Hearing Brief:	January 11, 2019
Complainant’s Reply Post-Hearing Brief:	January 25, 2019
Respondent’s Reply Post-Hearing Brief:	February 8, 2019

All briefs shall contain specific citations to the record and to any legal authority the party wishes for this Tribunal to consider. *See* 40 C.F.R. § 22.26 (requiring all post-hearing submissions to contain adequate references to the record and authorities upon which the filing party relied). If a party does not intend to file a post-hearing brief or reply brief as permitted above, it shall notify Matt Barnwell, a staff attorney for this Tribunal, at (202) 564-3245 or barnwell.matt@epa.gov.
