ORDER ON JOINT MOTION TO CONFORM TRANSCRIPT

The hearing in this matter was held in Cleveland, Ohio, from Monday, June 18, 2012, through Friday, June 29, 2012. The hearing was continued in Augusta, Georgia, on Monday, July 16, 2012. At the conclusion of the hearing, the parties agreed to produce a joint motion to conform the transcript shortly after receiving the final version from the court reporter. Thereafter, the court reporter provided the parties with copies of the final transcript. On Wednesday, July 25, 2012, the Regional Hearing Clerk confirmed that the final transcript had been incorporated into the official record in this case.
