
ORDER REQUIRING FURTHER PROCEDURAL FILING

On April 24, 1996, an Order to Show Cause was issued to Respondents as to why they should not be held in default for failure to submit their Prehearing Exchange by the due date in the Order Setting Prehearing Procedures. The Respondents, on May 23, 1996, filed their response to the Order to Show Cause, in which they indicated that their business premises were heavily damaged by flooding in March of 1995 and that, because of this disruption, they lost track of the due date for the Prehearing Exchange. The Respondents also note their and their counsel's inexperience with EPA enforcement actions. Further, the Respondents did include their Prehearing Exchange with their response to the Order to Show Cause. In light of the above, the Respondents have shown good cause for the failure to submit their Prehearing Exchange on a timely basis.

With the Prehearing Exchange now having occurred, this case is ready to be set for hearing. The Respondent has requested that the hearing be held in Santa Barbara, California, its place of business. Complainant asks that the hearing be conducted in San Francisco, California, the site of EPA's Regional Office. Pursuant to Section 22.21(d) of EPA's Rules of Practice, 40 C.F.R. § 22.21(d), Santa Barbara is the more preferred location and the hearing will be set there.

In addition, the parties are directed to confer and to suggest either an agreed upon or separate suggestions for a hearing date this Fall. In this regard, the parties are hereby advised that the Presiding Judge will be unavailable during the following periods: September 9-13; September 23-October 4; October 28-November 1; and November 14-20. The parties shall submit either their agreed upon or separate suggested hearing dates on or before September 3, 1996.
