At your request, as part of IEc's work under EPA Contract #GS-10F-0061N; Order #EP10H000898; Technical Directive #INT-15, concerning two Region 6 wetlands matters under one Respondent, Paco Swain Realty, L.L.C. ("Mr. Swain"), I am providing here support for my conclusion that <u>Mr. Swain has not demonstrated an inability to pay penalties</u>.

My conclusion here is based on the financial documents that Mr. Swain has provided to date, consisting of incomplete tax returns for the years 2005 through 2012, inclusive. That information is insufficient for me to perform a comprehensive and defensible ability-to-pay analysis for the following reasons:

- <u>Numerous</u> supporting forms and schedules for the tax returns provided are missing (see Attachment A and Attachment B for detail);
- The most recent tax return is for 2012, which is now more than a year out-of-date (the deadline for filing an extended 2013 return was October 15, 2014);
- The tax returns provided are all unsigned, lending questions regarding their credibility; and
- No information was provided concerning the nature or current value of Mr. Swain's living expenses, assets or liabilities (*e.g.*, bank accounts, investments, real estate holdings and any associated debts). Please see Attachment C, which needs to be completed and signed.

All of the missing and additional information should be readily available, and is the sort of data that I generally request and receive in similar matters involving ability-to-pay assessments, of which I have done many. If this information is provided to me in full, I should be able to complete the necessary analysis within a few weeks of receipt.

Thank you, Tucker.

Attached is the 2013 Return, which I had meant to send you before but evidently forgot to. We will have Mr. Swain fill out the form and return to you as soon as practicable. As you might recall, I had requested such a form before you referred the submission to IEC for analysis. Please strike this item from your motion to produce.

However, I must take issue with some of the consultant's conclusions, particularly as they relate to missing schedules. I have not looked at the returns for prior years, but from a perusal of the 2013 return, I suspect that most of the missing schedules were not included in the returns at all, as there is no need for a schedule that matches a blank line on the 1040. For instance, the current return has no Schedule B or D, or Form 4562 or 8562; nor does it include any data that require those information from those forms. All this is not to say that <u>no</u> forms are missing, although I am quite confident that the returns of which we provided copies were complete as they were filed.

Perhaps the analyst might have been able to more intelligently evaluate the issue had the matrix have been filled out; she might have no way of knowing that meadow Lake Holdings, Chateau de Chene and Megan's Way were defunct since 2010. But some of the comments are inexplicable, *i.e.*, the lack of signature on returns that were submitted by a licensed preparer with electronic signature (the returns should be evaluated as submitted, with a disclaimer if there is any doubt as to authenticity.

Aside from the Financial Data Request Form which we will have completed, we shall endeavor to find any inadvertently omitted schedules and clarify any disagreements between schedules and their corresponding lines on the form 1040. However, it is unlikely that we will attempt to prevail on Mr. Swain to conjure up imaginary schedules for items on which he had nothing to report. If Ms. Czerwonka does not understand this concept, I would be happy to explain it to her, or perhaps she might enlighten me as to the reason for such an exercise.

We hope you reconsider your intention to file a motion demanding "signed and complete" returns, until you have inspected the returns to determine their completeness, and also whether or not they were filed with electronic signature. Should you demand, for example, that a Schedule B must be submitted for years for which no Interest and Ordinary Income is reported, we would have to file opposition with supporting memorandum, rather than submit amended returns with no substantial changes (obviously they would have to be accepted by IRS before they are considered valid). It might be easier to have Paco simply sign a Form 4506 to have his returns sent directly to you or IEC, thereby eliminating all doubt as to their authenticity. If you will agree to that method, I will have him execute the form for every year in question.

Please let me know if there is anything further you need of us in the meantime.

As you are aware, I was able to procure some funding for a financial analysis in relation to Mr. Swain's inability to pay claim.
