In answer to the referenced complaint, the City of Breaux Bridge herein provides the following information:

- On April 28, 2014, the City transmitted to the US EPA the plan to implement the SWMP in the shortest time possible. The plan included the following milestone dates:
 - o Preparation and development of SWMP
 - Adoption of SWMP by Breaux Bridge City Council
 - Complete Implementation of SWMP
 - Monitoring, Recordkeeping, and Reporting

No response to this submittal has been received by the City.

- The City's progress toward these milestones is as follows:
 - Preparation and development of SWMP: The City has developed a draft SWMP. The City has made the draft Plan available to the public for comment until July 31. Once all comments are received and considered, the final SWMP will be completed.
 - Adoption of SWMP by Breaux Bridge City Council: The SWMP adoption will be on the agenda of the City Council meeting to be held August 12, 2014.
 - Once adopted, the SWMP will be implemented by August 31, 2014.
