
The United States Environmental Protection Agency Region 8 and BP America Production Company (hereinafter the “Parties”), respectfully submit this Joint Request for Extension of Stay of All Case Deadlines, and *Request for Expedited Ruling* as follows:

On January 30, 2015, the Parties filed Joint Notice of Settlement, Request for Stay of all Case Deadlines, and Request for Expedited Ruling. The Parties requested a 30-day stay. That request was granted on February 2, 2015.


The settlement in principle includes a supplemental environmental project and the Parties have been in consultation with the Southern Ute Indian Tribe to finalize a plan for that project. The Parties also have been exchanging proposed wording for the consent agreement to submit to EPA Region 8’s Regional Judicial Officer, and expect to reach agreement in the near future on the relevant wording of the consent agreement. Accordingly, the Parties request a 15-day extension of all case deadlines. The Parties will provide notice when the settlement has been finalized.

WHEREFORE, the Parties respectfully request their joint request for a 15-day stay of all case deadlines be GRANTED.


