### ORDER ON MOTION FOR EXTENSION OF TIME TO FILE PREHEARING EXCHANGES

The Prehearing Order issued in this proceeding set filing deadlines for the parties to submit their respective prehearing exchanges and report on the status of settlement negotiations. An Order issued September 10, 2014, granted a 30 day extension to allow the parties to ascertain the feasibility of a Supplemental Environmental Project and negotiate a settlement agreement. The due date for Complainant's prehearing exchange is currently October 20, 2014.

On October 15, 2014, Complainant filed a motion requesting an additional 30 days for each party to file prehearing exchanges. Grounds stated in this motion are that the parties' have made significant progress toward settlement and both parties are currently reviewing a draft Consent Agreement and Final Order ("CAFO"). The motion represents that Respondent's counsel joins in this extension request.

The Rules of Practice governing this proceeding, 40 C.F.R. Part 22, provide at 40 C.F.R. § 22.7(b) that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties." Given the status of settlement in this matter there is good cause to grant the requested 30-day extension.

Therefore, the motion is hereby **<u>GRANTED</u>** and the deadlines for the prehearing exchanges are extended as follows:
