COMES NOW Complainant, the U.S. Environmental Protection Agency ("EPA"), through the undersigned attorney, and respectfully alleges, prays and requests as follow:

Pursuant to the March 6, 2017 Prehearing Order (the "Order") issued by the Administrative Law Judge, Honorable Christine D. Coughlin, the parties were ordered to file a statement identifying the party's preference for the location of the hearing on or before March 24, 2017.

Pursuant to 40 C.F.R. §§ 22.21(d) and 22.19(d), the hearing should be held in the county where the Respondent conducts business which the hearing concerns, in the city in which the relevant Environmental Protection Agency Regional office is located, or in Washington, D.C.

Complainant requests that the hearing be held in San Juan. Respondent is a foreign for profit limited liability company authorized to do business in Puerto Rico and its designated office and resident agent are located in San Juan.

Furthermore, EPA's relevant office is located in Guaynabo, which is within the San Juan metro area.

Holding the hearing in the San Juan is more convenient for both parties than the Municipality of Fajardo, where the events that gave rise to this action occurred, or Washington, D.C. The Complainant can assist by providing the Hearing Clerk with information on facilities which may be available for purposes of holding the hearing.
