The Rules of Practice that govern this action authorize me to limit the disclosure of information produced under a claim of business confidentiality. *See* 40 C.F.R. § 164.4(c) (“Whenever any information or data is required to be produced or examined and any party to the proceeding claims that such information is a trade secret or commercial or financial information, other than information relating to the formulas of a pesticide, the Administrative Law Judge . . . may require production or testimony in camera and sealed to all but the parties.”); 40 C.F.R. § 164.40(d) (“[T]he Administrative Law Judge shall have power to take actions and decisions in conformity with statute or in the interests of justice.”).

Having reviewed the proposed Protective Order and upon due consideration, the Joint Motion for Entry of Protective Order is GRANTED. The Protective Order’s terms are adopted as if set out herein.
