ORDER ON JOINT MOTION TO STAY CASE SCHEDULE

I previously issued orders in this matter setting deadlines for filing dispositive and prehearing motions and scheduling a hearing to begin February 22, 2021. *See* Amended Order Scheduling Hearing (Sept. 18, 2020).

On October 16, 2020, the Agency filed a Motion for Partial Accelerated Decision as to Liability. On October 19, 2020, the parties filed a Joint Motion to Stay Case Schedule (“Joint Motion”). In the Joint Motion, the parties request that deadlines imposed by the Amended Order Scheduling Hearing be stayed until the Agency’s Motion for Partial Accelerated Decision is resolved.

Under the rules governing this proceeding, I “may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon [my] own initiative.” 40 C.F.R. § 22.7(b). The parties have shown good cause for staying the deadlines in this proceeding.

Accordingly, the Joint Motion is **GRANTED**. All of the prehearing deadlines set forth in the Amended Order Scheduling Hearing are stayed pending a ruling on the Agency’s Motion for Accelerated Decision.
