**COMPLAINANT’S SUPPLEMENTAL
PREHEARING EXCHANGE**

Pursuant to 40 C.F.R. § 22.19 and the Presiding Officer’s January 28, 2025, Prehearing Order, Complainant U.S. Environmental Protection Agency (“EPA” or “Complainant”) submits this Supplemental Prehearing Exchange.

Update Regarding Public Notice for the Second Amended Complaint

On December 17, 2025, this Tribunal granted Complainant’s motion for leave to file a Second Amended Complaint.¹ Pursuant to Clean Water Act Section 311(b)(6)(C), 33 U.S.C. § 1321(b)(6)(C), and 40 C.F.R. § 22.45(b), Complainant provided public notice and reasonable opportunity to comment on the Second Amended Complaint via the internet. The public notice period commenced on December 22, 2025.² Complainant’s Initial Prehearing Exchange provided a copy of this public notice,³ but was filed on January 16, 2026, prior to the expiration of the public notice period. The public notice period expired on January 21, 2026.⁴ Complainant submits this Supplemental Prehearing Exchange to notify this Tribunal that the EPA Region 10 Regional Hearing Clerk did not receive any public comments.
