RESOLUTION NO. 867 B

WHEREAS, the Board of Commissioners of Flathead County, Montana, adopted the Flathead County Air Pollution Control Program and Regulations, as authorized by Section 75-2-301, M.C.A. by the adoption of Resolution No. 867, on October 3, 1991;

WHEREAS, the Board of Commissioners amended the Flathead County Air Pollution Control Program and Regulations by the adoption of Resolution No. 867A, on October 12, 1993, by, (i) incorporating contingency measures into the Columbia Falls and Kalispell Air Pollution Control Districts, to require use of liquid deicer in the event that either non-attainment area does not meet the National Ambient Air Quality Standards for particulate matter; (ii) expanding the boundaries of both districts; and (iii) changing the open burning portion of the regulations which deals with the open-burning disposal of Christmas trees;

WHEREAS, the City Council of the City of Columbia Falls, Montana, has recommended that the Board of Commissioners amend the Flathead County Air Pollution Control Program and Regulations by modifying the boundaries of the Columbia Falls Air Pollution Control District to reduce the area covered by that District to include the area within the city limits of Columbia Falls, Montana.

WHEREAS, the Board of Commissioners held a public hearing on April 4, 1994, to consider the proposed amendment, after publication of notice thereof on March 24 and March 31, 1994; and

WHEREAS, the Board of Commissioners reviewed the public testimony and the recommendation of the City Council of the City of Columbia Falls, Montana.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Flathead County, Montana, in accordance with Section 75-2-301, M.C.A., hereby amends the Flathead County Air Pollution Control Program and Regulations to reduce the area of the Columbia Falls Air Pollution Control District to include the area within the city limits of Columbia Falls, Montana.

BE IT FURTHER RESOLVED that the Flathead County Air Pollution Control Program shall henceforth be governed by the regulations attached hereto and made a part hereof by this reference.
