## NOTICE OF PROPOSED REVISION TO TITLE V PERMIT

This notice is to inform you that the South Coast Air Quality Management District (AQMD) has received applications for the permit revisions described below and intends to issue a revised Title V permit. The AQMD is the air pollution control agency for all of Orange County and portions of Los Angeles, Riverside and San Bernardino Counties. Anyone wishing to operate, install or modify equipment that could be a source of air pollution within this region must first obtain permits from the AQMD. For certain projects, such as this one, Rule 3006 (Title V) requires publication of a public notice prior to the issuance of a permit.

The AQMD has evaluated the permit applications for the following equipment and determined that the equipment will meet all applicable air quality requirements of our Rules and Regulations.

**APPLICANT:** ConocoPhillips Company, Wilmington Refinery  
**FACILITY ID NO.:** 800363  
**FACILITY LOCATION:** 1600 W. Anaheim Street, Wilmington, CA 90744  
**PROJECT DESCRIPTION:** Replace the external floating roof on a storage tank and add a geodesic dome roof cover

The facility is a petroleum refinery which, along with ConocoPhillips' other refinery located in Carson, processes crude oil into products such as gasoline, diesel, jet fuel and petroleum coke. The project modifies an existing external floating roof storage tank to replace the external floating roof, add a geodesic dome roof cover and use the tank to store recovered oil at the Wilmington Refinery. This facility will use the best available technology for controlling air pollution. Our calculations show that, based on a 30-day average, a maximum of 3.98 pounds of Volatile Organic Compounds will be emitted from the tank in any one day.

As required by Title V of the federal Clean Air Act, the AQMD will revise the existing Title V permit of this facility to reflect the modification of the equipment at this facility. The revised Title V permit shall include all of the emission limits and operating conditions in the proposed Permit to Construct / Permit to Operate for the above mentioned equipment. The facility shall be required to certify compliance with the revised Title V permit in addition to recordkeeping and mandatory reporting of any violations of the permit conditions. The revised Title V permit shall be enforceable by the AQMD, by the federal government, and by citizens.

The air quality analysis of this project and the proposed permit are available for public review during normal business hours at the AQMD, 21865 Copley Drive, Diamond Bar, CA. Information regarding the facility's compliance history submitted to the AQMD pursuant to California Health & Safety Code Section 42336, or otherwise known to the AQMD based on credible information, is also available from the AQMD for public review.

The public may request the AQMD conduct a public hearing on the proposed Title V permit by submitting a Hearing Request Form (Form 500-G) to Mr. Jonathan Uhl at the above AQMD address. The AQMD will hold a public hearing if there is evidence that the proposed Title V permit is incorrect or inadequate to ensure compliance with regulatory requirements, and that a public hearing will likely provide additional information that will affect the drafting and/or issuance of the permit.
