NOTICE OF PROPOSED TITLE V RENEWAL PERMIT

This is an existing facility applying for a Title V permit renewal that is engaged in glass and ceramic lamp manufacturing. The facility operates spray booths, a baking oven, a nickel plating line, a clay mixer, a wastewater separator, and other supporting equipment.

Pursuant to Title V of the federal Clean Air Act and AQMD Rule 3004(f), a Title V permit shall expire five years from the date of issuance unless such permit has been renewed. Accordingly, the above facility has submitted a Title V renewal application and requested the AQMD to renew their Title V permit. The proposed permit incorporates updates to the facility information provided in the facility's Title V renewal application and all rules and regulations that are currently applicable to the facility.

The proposed permit is available for public review at the AQMD, 21865 Copley Dr., Diamond Bar, CA 91765 and at the Gardena Mayme Dear Library, 1731 W. Gardena Blvd., Gardena, CA

Comments must be received by September 12, 2011. The AQMD will consider all public comments and may revise the Title V permit in accordance with AQMD rules and regulations.

The public may request the AQMD to conduct a public hearing on the proposed permit by submitting a Hearing Request Form (Form 500-G) to Hamed Mandilawi at the above AQMD address. The AQMD will hold a public hearing if there is evidence that the proposed permit is not correct or is not adequate to ensure compliance with regulatory requirements, and a hearing will likely provide additional information that will affect the drafting and/or issuance of the permit. A copy of the hearing request must also be sent by first class mail to the facility contact person listed above.
