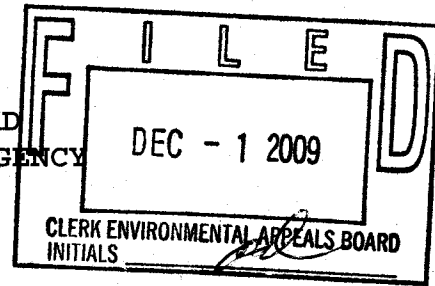

ORDER GRANTING REGION'S MOTION  
FOR EXTENSION OF TIME

On November 24, 2009, U.S. EPA Region 10 ("Region") filed a motion seeking a single response date and an extension of time to file its response to Appeal No. 09-12 and Appeal No. 09-13. Currently, the Region has until December 8, 2009, to file its response to Appeal No. 09-12 and until December 14, 2009, for Appeal No. 09-13. The Region is requesting until January 11, 2010, to file its response briefs. In support of its request, the Region explains that due to the issues raised in both petitions, it will need to coordinate extensively with EPA Headquarters, and, due to the proximity of the holidays, it anticipates difficulties in scheduling meetings and conference calls with the appropriate Headquarters' personnel. The Region represents that it contacted both petitioners and that the Idaho Conservation League (Appeal No. 09-13) does not object to the

request for extension of time, but that the City of Twin Falls (Appeal No. 09-12) did not indicate whether it will oppose the motion.

Upon consideration, the Board hereby grants the Region's request. Accordingly, the Region must file its response briefs to each of the petitions no later than Monday, January 11, 2010.
