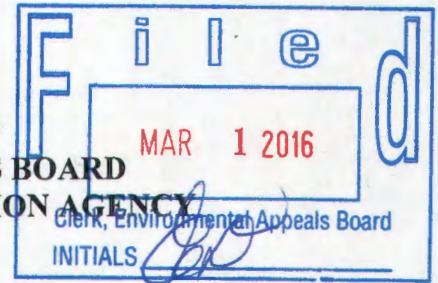

SEVENTH ORDER EXTENDING STAY OF PROCEEDINGS

By order dated January 13, 2016, the Environmental Appeals Board extended the stay of proceedings in the above-captioned matter until March 1, 2016, to allow the parties to continue participating in the Board's Alternative Dispute Resolution program. The parties filed a "Notice of Provisional Settlement" on January 6, 2016, and EPA Region 8 had anticipated taking final action on Deseret Power's application for a minor new source permit by late February. The Settlement Judge now recommends that the Board extend the stay until March 24, 2016, to provide the parties additional time to complete all necessary tasks to implement the settlement, and for petitioners to file motions for dismissal with the Board.

Based on the recommendation of the Settlement Judge, the Board extends the stay until March 24, 2016.


