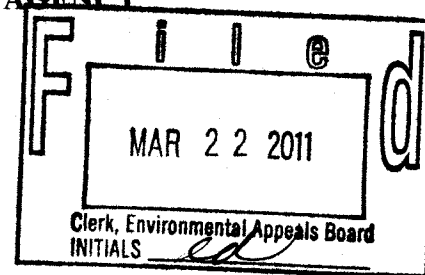

ORDER SCHEDULING STATUS CONFERENCE

The Sierra Club has filed a petition requesting that the Environmental Appeals Board (“Board”) review certain conditions of a Clean Air Act prevention of significant deterioration (“PSD”) permit the Illinois Environmental Protection Agency (“IEPA”) issued to Mississippi Lime Company (“MLC”) to construct a lime manufacturing plant in Rudolph County, Illinois. Petition for Review and Request for Oral Argument (Jan. 26, 2011) (“Petition”). Pursuant to two previously issued Board orders, IEPA’s response to the Petition must be filed with the Board no later than April 15, 2011, and MLC’s response must be filed no later than April 29, 2011. See Order Granting Motion for Extension of Time to File Certified Administrative Record and Response (Feb. 15, 2011); Order Granting [MLC’s] Motion to Participate and to File Separate Briefing (Mar. 1, 2011).


After reviewing the Petition, and in light of the Board’s recently issued decision in *In re Vulcan Construction Materials, LP*, PSD Appeal No. 10-11 (EAB Mar. 2, 2011), 15 E.A.D. ____, the Environmental Appeals Board has determined that a status conference would be beneficial at this juncture. Accordingly, counsel for the Sierra Club and IEPA, are hereby requested to participate in such a conference beginning at 10:30 a.m. EST on Thursday, March 31, 2011.

Counsel for MSL may also participate in the status conference. The Board will initiate the status conference from the Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building, 1201 Constitution Avenue, N.W., Room 1152, Washington, D.C. Counsel may choose to appear in person in the Courtroom or may participate via telephone or video-conferencing equipment. Counsel must contact the Clerk of the Board in writing no later than Monday, March 28, 2011, to advise how they wish to participate in the conference and to provide telephone numbers or other contact information as appropriate.


