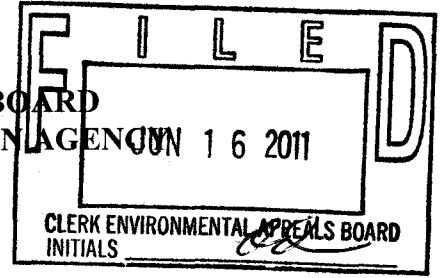

**ORDER GRANTING MOTION FOR SECOND EXTENSION OF TIME TO FILE
RESPONSE AND LEAVE TO CONDUCT SETTLEMENT DISCUSSIONS**

On May 9, 2011, the Environmental Appeals Board granted a motion filed by U.S. Environmental Protection Agency ("EPA") Region 6 ("Region") for an extension of time to file its response in the above captioned matters and for leave to conduct settlement discussions with AMRECO, LLC. The Board ordered the Region to file a response to AMRECO's appeal no later than June 20, 2011. By motion dated June 15, 2011, the Region now moves for a second extension of time, until August 1, 2011. Motion for Second Extension of Time and Leave to Conduct Settlement Discussions ("Motion").

Counsel for the Region represents that he and a representative of AMRECO, Mr. Jon Tarver, spoke by telephone on or about June 13, 2011. The Region's motion adds:

In addition, Mr. Bryant Smalley, the [Region's] Program Officer assigned to the case, has also had several settlement discussions with Mr. Tarver since May 9, 2011. At each such settlement discussion, Mr. Tarver continues to express desire to settle the case, and both parties believe there is a reasonable basis for settling

the matters raised in the initial Complaint and in Respondent's hand-written letter.

Motion at 1. Accordingly, the Region requests a stay in the proceedings until August 1, 2011 to allow the parties an opportunity to continue settlement discussions.

For good cause shown, the Region's requests for extension to file its response and for leave are **GRANTED**. The Region's response to the appeal is to be filed no later than **August 1, 2011**.


